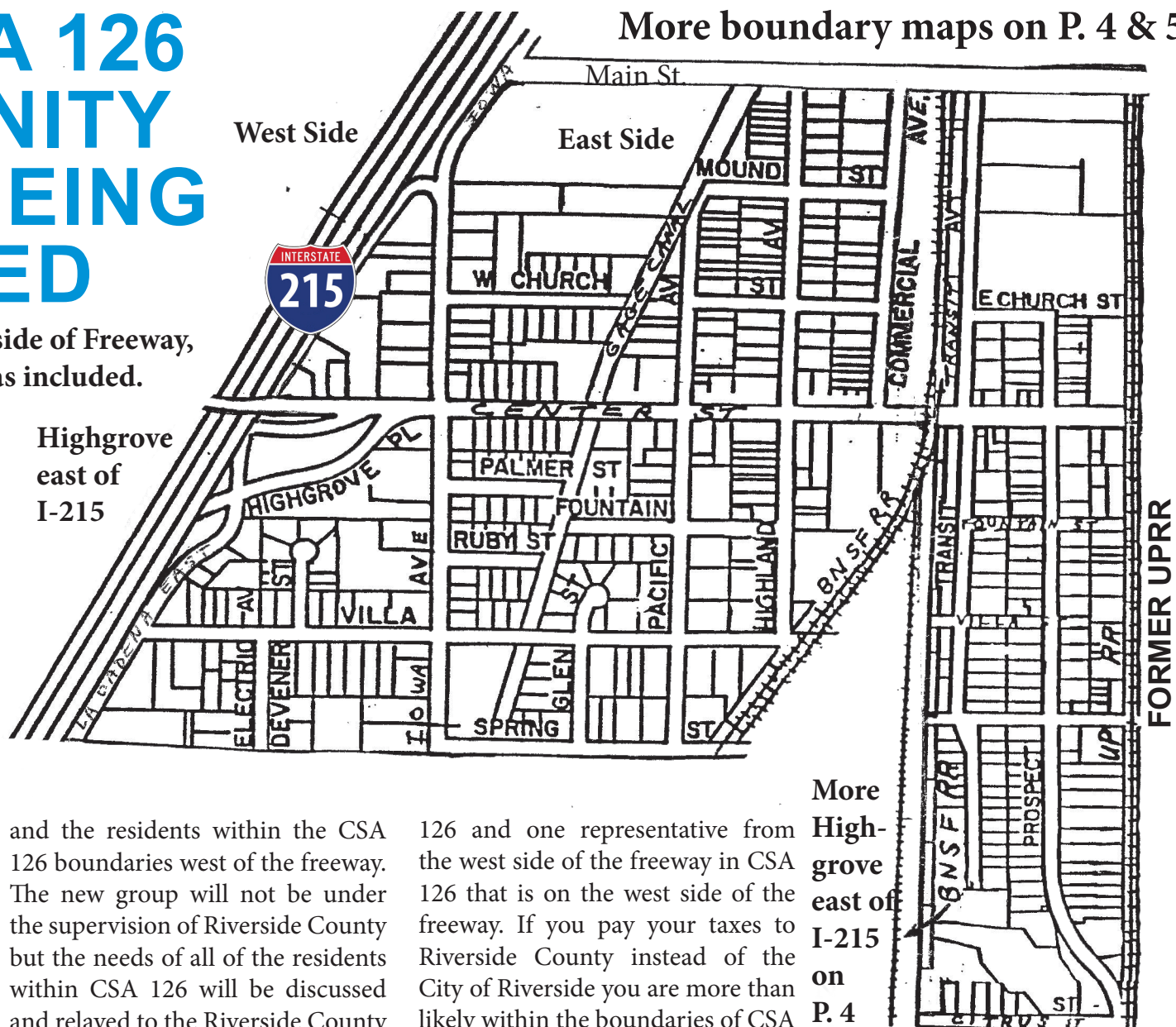
### NEW CSA 126 COMMUNITY GROUP BEING FORMED

**Spring Mountain Ranch, East side of Freeway,  
West side of Freeway- all 3 areas included.**

If you live within the boundaries of this map you are encouraged to attend the next Highgrove Community meeting at 7:00 pm on August 10, 2017 at the Norton Younglove Community Center located at 459 Center St. in Highgrove. CSA 126 is the designation given to the Highgrove area on both sides of the I-215 freeway. CSA stands for County Service Area and CSA126 is on both sides of the freeway. The boundary on the north is the Riverside/San Bernardino county Line at Main Street, the boundary on the east is the base of the foothills east of Spring Mountain Ranch, the boundary on the south is the city limits of Riverside and the boundary on the west is on the west side of the I-215 freeway on the east side of North Orange Street.

Since the loss of the Highgrove Sheriff on the east side of the freeway and the elimination of the Highgrove Municipal Advisory Council by Supervisor Tavaglione, a new community group is being formed that will represent all residents within CSA 126 including residents in Spring Mountain Ranch, the older part of Highgrove

and the residents within the CSA 126 boundaries west of the freeway. The new group will not be under the supervision of Riverside County but the needs of all of the residents within CSA 126 will be discussed and relayed to the Riverside County Board of Supervisors.

Residents on both sides of the freeway are encouraged to attend the open meeting at 7:00 pm at the Norton Younglove Community Center located at 459 Center St. on Aug. 10, 2017.

A suggestion has been made to create a community group with one representative from Spring Mountain Ranch, three representatives from the east side of the freeway in CSA

126 and one representative from the west side of the freeway in CSA 126 that is on the west side of the freeway. If you pay your taxes to Riverside County instead of the City of Riverside you are more than likely within the boundaries of CSA 126. On the west side of the freeway, along North Orange St., the west side of the street is within the Riverside City limits but the east side of North Orange St. between Center St. and the Springbrook wash has some residences within CSA 126. Check your tax records to see if you pay taxes to Riverside County or the City of Riverside. Call 951-683-4994 for assistance.

## TRANSPORTATION ISSUES: YES SOMEONE IS WATCHING!

In a Press Enterprise article on July 11, 2017 there was an article about the Mid County Parkway surviving an environmental lawsuit against the Riverside County Transportation Commission under the California Environmental Quality Act. The Press Enterprise article states that the “opponents say the project would displace 99 homes and 26 businesses in Perris, affecting 396 residents and 171 employees.” Also, according to the Press Enterprise article Supervisor Tavaglione, who is also the Chairman of the Riverside County Transportation Commission, stated: “We have made a concerted effort to develop a project that meets future transportation needs while protecting the environment and the ruling proves that.” After reading the article I couldn’t keep from thinking that I know a place at Highgrove that is already owned by the Riverside County Transportation Commission that is a vacant field that would meet present and future transportations needs that would also not affect the environment, and would not displace 99 homes, and would not affect 26 businesses and would not affect 396 residents or 171 employees. If you read our newspaper you know that the Highgrove location is a perfect place for a Metrolink station that has been supported for 15 years by everyone but RCTC. Unfortunately, I cannot ever mention the Highgrove Metrolink location again to RCTC Chairman/ Supervisor Tavaglione because on March 8, 2017 at the RCTC

meeting I asked if the RCTC’s Commissioners could take a bus field trip to Highgrove to actually see the Highgrove location either before or after the April 12, 2017 RCTC meeting. Chairman Tavaglione, became so upset that not only did he refuse to let the RCTC Commissioners take the pre-arranged RTA bus trip and refuse to put me on the April 12th RCTC agenda to answer questions, on that same day after the RCTC meeting he wrote a letter using his position as Supervisor Tavaglione to call for a Public Hearing to cancel the entire Highgrove Municipal Advisory Council which I have been Chairman for many years. The Highgrove Municipal Advisory Council and its predecessor, County Service area 126, were created by the Riverside County Board of Supervisors to enable communities in their district to communicate with their County Supervisor. Each Supervisor is also a member of the Riverside County Transportation Commission. But why did Tavaglione use something that happened during a meeting where he presided as Chairman of of the Riverside County Transportation Commission to eliminate something else (the Highgrove MAC) that was created by the Riverside County Board of Supervisors? The 30 RCTC Commissioners have no authority to eliminate a community organization that was created by the Riverside County Board of Supervisors. On March 8, 2017 RCTC Chairman Tavaglione would not allow the 30 RCTC Commissioners to take a pre-arranged bus trip to Highgrove to see the location of the property they own that is needed for a Metrolink station at Highgrove and

he would not put me on the April 12, 2017 RCTC agenda. His position as Chairman of RCTC somehow influenced his other position as Supervisor because right after the RCTC meeting on March 8, 2017, RCTC Chairman Tavaglione changed hats and wrote a letter and signed it as Supervisor Tavaglione calling for a public hearing to eliminate the entire Highgrove Municipal Advisory Council. Eliminating the Highgrove MAC was inappropriate even if he opposed something that occurred during another type of meeting where he was chairman. I had already resigned from the Highgrove Municipal Advisory Council on March 15, 2017, almost 1 month before the public hearing, so there was no reason to eliminate the other 5 Highgrove MAC members at the public hearing on April 11, 2017. Eliminating the entire Highgrove MAC after I resigned was an injustice to the people of Highgrove! Meanwhile RCTC’s 17.22 acre property at Highgrove sits empty that could easily be made into a parking lot so commuters could park and ride Metrolink on the 7 day a week trains to Oceanside in one direction or San Bernardino in the other direction. To put this in perspective the Mid County Parkway is estimated to cost \$2 Billion dollars paid for partially through Measure A’s ½ cent sales tax that was approved by the Riverside County voters. At Highgrove, RCTC already has

\$5,347,500.00 invested in vacant property that they do not need and guess what....that \$5,347,500.00 is also Measure A money! Maybe some of that \$2 Billion dollar Mid County Parkway Measure A “Transportation” money should be spent to grade RCTC’s property for a parking lot at Highgrove. That small cost would enable commuters to use the existing daily Metrolink commuter trains between the 2 counties, help reduce freeway congestion, and be a more cost effective way to distribute our transportation dollars. Building more roads is not the only answer to solving our crowded freeway problems. But our local “Transportation” Agency has ignored the wishes of the people for 15 years while the existing daily Metrolink trains continue to go between the 2 counties every day of the week including weekends. RCTC owns excess vacant land that is right next to the track where Metrolink trains pass by in both directions. But this “Transportation” Agency is set against stopping some of these daily trains at Highgrove. Its too bad that the Commissioners were not allowed to see this location because it brings up another question: How many tons of air pollution would have been eliminated since July 15, 2006 when Metrolink trains increased to 7 days a week? In 11 years over 35,000 Metrolink trains would have parked a lot of cars. And remember: **A parked car emits no Air Pollution!**

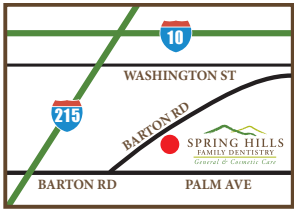

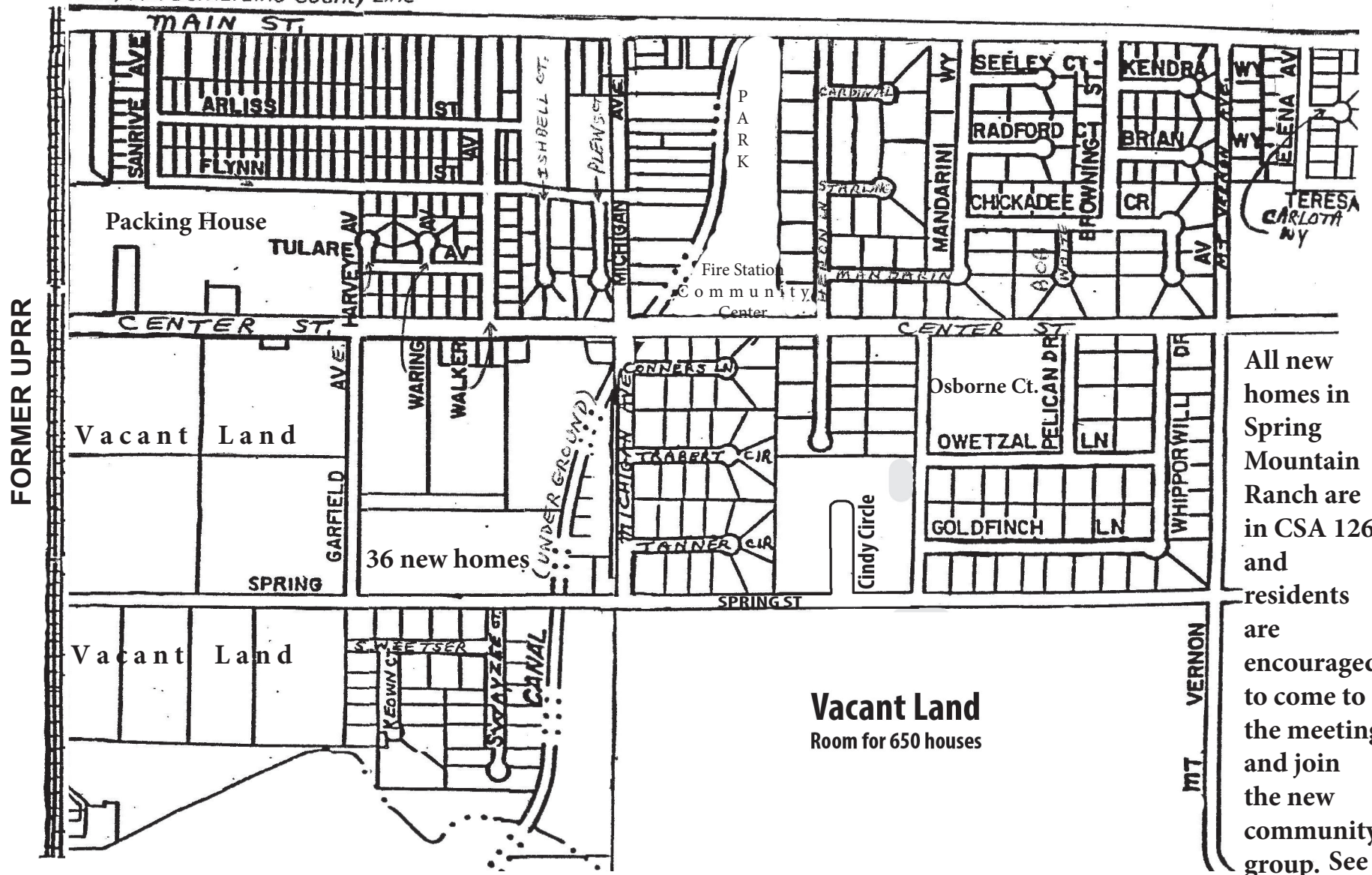

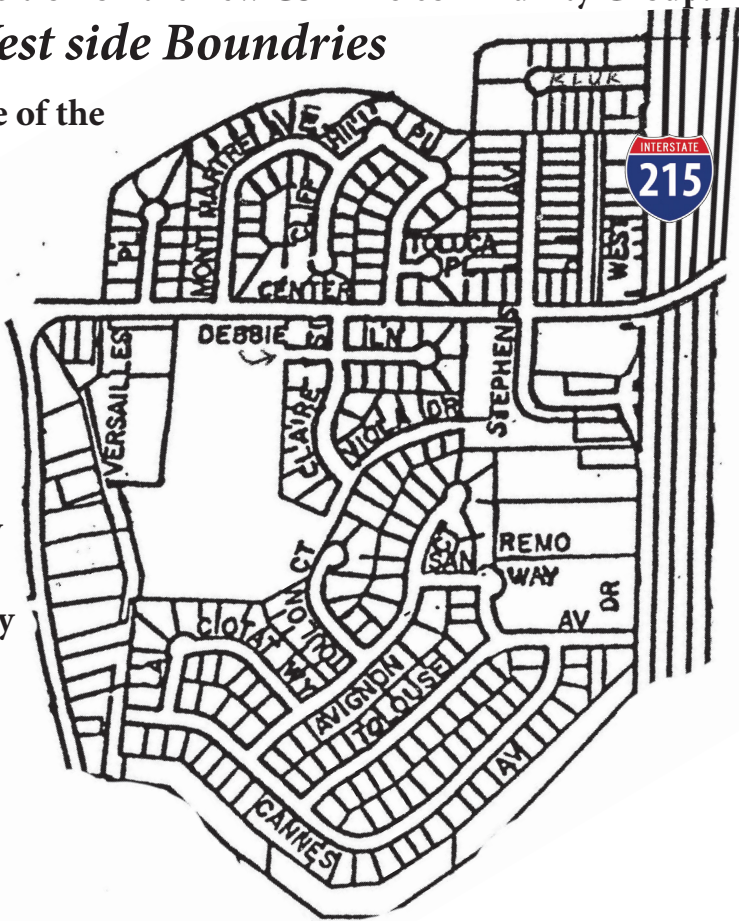

### Golf in the Inland Empire

The inland Empire is blessed with some of the very best golf weather in the country. With the exception of a few very hot days in the summer, and very few rainy and cold days in the winter, a golfer can play all year round.

Unlike many sports, a golfer can play until he keels over. I recently played with a man that is 93 years old.

A golf course is a beautiful addition to the community. The trees, shrubbery, grass, and flowers, add to the replenishing of oxygen back into the environment. I am now immune to, and have distaste for, the term green. So I will not go there. Suffice it to say that a golf course is many times more pleasant to look at than a slab sided

warehouse, or shopping mall.

We are very rapidly losing our local golf courses. Rancho Verde in Rialto, El Ravino in Bloomington, Riverside Golf Club in Riverside, and Empire Lakes in Ontario, are gone. Moreno Valley Ranch is closed, but rumored to reopen, we hope. I'm told that Calimesa Golf club is on the bubble. Additionally, San Bernardino Golf Club is set to close in the fall of next year.

The problem is that the real estate that a golf course is sitting on is more valuable to an investor to develop for a mall, houses, apartments, or warehouses.

So we lose the open spaces to cramming in more people into our neighborhoods. Worse yet is to put up a mega-warehouse. So, a giant warehouse is built, gobbling up acres of land, to employ a

## 1997 "IMPARTIAL ANALYSIS" EXPLAINS USE OF ANNUAL PARCEL ASSESSMENT

This special self-imposed tax was created for only 2 specific purposes. The 1997 "Impartial Analysis" written by Riverside County Council William C. Katzenstein states:

**"The tax will be retained in the CSA 126 fund to be used only for purposes of continuing Extended Sheriff and Park & Recreation services and improvements".**

If the Extended Sheriff position was eliminated 7 ½ years ago and there were no improvements to Highgrove's only 5 acre park, the Highgrove property owners deserve to know where their money went!

If any money was given to the Sheriff Department for any other purpose except for Highgrove's Extended Sheriff, then there is a problem!

And if there were improvements made to the Highgrove Community Park why does the park look the same as it did on October 16, 1999 when it was dedicated?

But regardless of whether or not the money was actually **"retained"** in the CSA fund as instructed by county council, the Highgrove property owners need to know the exact amount of income that was generated from this special assessment after the Sheriff was eliminated on Dec. 30, 2009. Riverside County Tax records from the Auditor-Controller's office will show how much was collected each year for fund # 68-1883 which is the district number for the parcel assessment.

More importantly the Highgrove property owners need to have an exact breakdown that shows the amount of expenses taken from the CSA 126 Fund since Dec. 30, 2009, who the money went to, and how much money is presently in the CSA 126 fund!

## Is legal action necessary?

Talking to an Attorney about the parcel fees and the Highgrove Sheriff has been previously discussed at our former MAC meetings.

The audit of our CSA Funds that was given to Supervisor Tavaglione on Aug. 5, 2015 and returned on Jan. 12, 2016 created more questions than answers. Then nine months later, on October 11, 2016 a special public meeting

Golfers don't generally want or need the community to finance their play, as do most every other sport.

Think about it, football, baseball, soccer, and tennis are supported by our tax- supported schools, and all have facilities for all those sports. At a higher level cities build baseball, and football stadiums, with tax dollars to attract professional teams.

Maybe our communities and elected officials should consider giving golfers some of the same breaks that are given other sports.

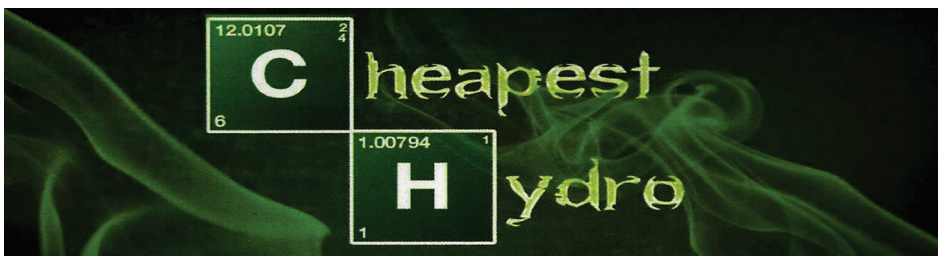

was held at the Norton Younglove Community Center in Highgrove and the only thing on the agenda was about the Parcel Fees and the Highgrove Sheriff. Supervisor Tavaglione was invited but he did not attend. (The regular MAC meeting was held 8 days later on Oct. 19, 2017 at the Highgrove library.)

Residents who attended these meetings have asked why they are still having to pay \$120.00 per year for a Highgrove Sheriff that was eliminated several years ago! But instead of seeking legal council the MAC decided to submit questions directly to Supervisor Tavaglione in order to keep the relationship open between the Highgrove MAC and Supervisor Tavaglione's office.

Then on Nov. 16, 2016, 27 questions were given to Supervisor Tavaglione in order to give the county a chance to answer the questions before obtaining legal council.

Question number 22 of the 27 questions states: "Will Riverside County refund the tax payers money that was collected after the Highgrove Sheriff's position was eliminated,

or will legal action be required?"

The answer was "No refunds!"

So that is why we have been talking to an Attorney!

Still, after all of these efforts, 3 or 4 of the tax payers do not want to agitate Supervisor Tavaglione any further by pursuing legal action against Riverside County. They seem to forget that Supervisor Tavaglione is the one who is responsible for the friction between him and the Highgrove residents by not attending our monthly meetings, sending a representative from his office to our meetings every other month and not sending any county representative to our MAC meetings on January 18, 2017 (when the answers to the 27 questions were due), or to the Feb., or March 2017 meetings and then eliminating the MAC 8 days before the MAC's April 2017 meeting.

It cannot get much worse because after 25 years, Supervisor Tavaglione eliminated the only collective voice of the Highgrove people by silencing the Highgrove MAC.

A. A. Milne: *"Weeds are flowers too, once you get to know them!"*



As a Master Gardener, I think I can agree with Mr. Milne. Weeds are usually considered invaders and pests; they aren't wanted and are so unloved. There's a whole industry is dedicated to hunting down and eradicating the eyesores with diggers, clippers, poisons and potions.

In the past few years our definition of "weed" has evolved and we are starting to rethink the value of weeds.

Weeds, as we regard them, are an integral part of the ecosystem. Many little critters depend on the foliage and blooms for their food. (My daughter bought weed seeds for her desert tortoise and planted a patch of weeds specifically for the little girl!). One life form has a huge dependence on the weed flowers- the bees. Having some flowering weeds around your plants and trees that depend on bees for pollination will help attract them to your area.

With the threat of extinction of bees a very real possibility, all of their food sources are being re-examined. Weeds usually have blooms- for their survival they want to attract bees and other pollinators. You have probably seen the news and the illustrations about the critical role bees play in the pollination of our food plants. The graphics of grocery shelves being bare due to no pollination is not an exaggeration. It is a very real risk and a likelihood with the trend as is.

Why is there a problem now? What has changed in the past decade? It's not just one thing but several failures along the cycle of life for bees is creating a cataclysmic failure. Most significant is

the lack of food source. Blooming weeds, ornamental flowers, grasses, and flowering trees are all significant food sources for bees. They attract the bees who capture pollen on their little legs and transfers it from plant to plant as they seek nectar from the blooms. The tremendous overuse of pesticides, the loss of acres plants due to "development" (for example: the destruction of orange groves to build houses), and the excessive toxins in the environment that kill off the bee populations are all to blame for the crisis.

Eldridge Cleaver:

*"There is no more neutrality in the world. You either have to be part of the solution, or you're going to be part of the problem."*

As with many other ills of the world, one person alone cannot remedy them. But as with many other problems, if each person does their bit, all those bits add up to a solution. Plant items that are appealing to bees- flowers, blooming trees and vegetables all have nectar that the bees will flock to. Let the bee-friendly weeds live- embrace their blooms knowing you are helping them. Purchase organic produce and other organic foods- the organic farmers' commitment to not using pesticides should be encouraged and rewarded.

One word about the danger of bees- they aren't dangerous unless you have a specific allergy to them. Keep very calm around them, no swatting or waving at them, and they will just go about their business.

Enjoy their presence because they are a serious player in the food chain.

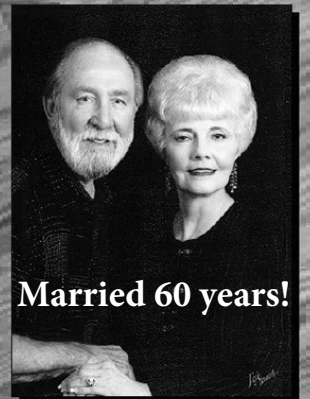

And when Supervisor Tavaglione says his door is always open he must have a back door because on March 7, 2016 Supervisor Tavaglione requested a meeting with MAC members Barnett, Boal and Yu but Supervisor Tavaglione did not attend. We met with John Field, Chief of Staff and Jason Farin, Legislative Representative. Then almost 1 year later when MAC Chairman "Barney" Barnett and MAC Vice Chairperson Becky Luther were called to Tavaglione's office on Feb. 22, 2017, Supervisor Tavaglione was absent again. We met again with Mr. Field and Mr. Farin and Suzanne Holland from the Riverside County E D A. We have no problem talking to the staff but they are not our County Supervisor. Another meeting was requested but Supervisor Tavaglione said another meeting was not necessary.

At the Public Hearing Supervisor Tavaglione asked Highgrove resident Becky Luther to be the contact

person to relay information to him about Highgrove. At this point, the community needs Beck Luther to be the contact person because she is still able to talk to him because of their previous relationship when she worked for the State Fire Agency and had dealings with Riverside County.

Remember on July 1, 2017 another fiscal year started and you will see the \$120.00 on your next tax bills again. 430 new homes in Spring Mountain Ranch are now paying the annual fee of \$120.00 into the CSA 126 fund and another 36 homes have been added in the Meridian Pointe project on the corner of Spring and Garfield by the school.

Due to the increase in funds being added to CSA126 fund we may want to consider getting our own Sheriff back once a legal settlement is made. Meanwhile we are still paying for a designated Sheriff that we have not had for the last 7 1/2 years.
