DUI COLLISION KILLS ONE: DRIVER ARRESTED Where is the

On November 11, 2011 at approximately 8:40 p.m., Mr. Justin Lee Kirby (27, Riverside) was allegedly driving his Honda Accord traveling southbound on Iowa Ave. just north of East La Cadena Dr. in Highgrove at approximately 45 MPH. Mr. Kirby allowed his Honda to travel off the roadway where it struck a palm tree. As a result of the impact, the Honda overturned; ejecting the right rear passenger onto the roadway. The passenger (male, 24, Riverside) died on scene as a result of his injuries. Mr. Kirby's two remaining passengers, Ms. Paige Nace (female, 21, Riverside) and Ms. Amber R. Lafortune (female, 23, Riverside) were transported to Riverside Community Hospital with minor injuries.

Investigating officers determined that Mr. Kirby was operating his vehicle while intoxicated. He was arrested and booked at Robert



Preseley Detention Center with a parole hold with pending charges of 23153(a)VC- Felony DUI, 23153(b) VC- DUI with a BAC of .08% or greater, and 191.5(a)VC- Gross Vehicular Manslaughter while intoxicated.



Where is the *"Highgrove"* in "Highgrove Community Plan"?



New Highgrove Community Plan requested!

A new plan for the Highgrove Community is needed. The last one was in 1999 and included 61 different agencies but did not include anyone from Highgrove! The above headline appeared in the June 1999 issue of the Highgrove Happenings and was taken from our archives.

Many things have changed since the last community plan including the economy and related construction planned in our community. Here are some of the changes that have occurred since the last Highgrove Community Plan:

#### (1) Bixby Land Co.

The zoning for the 40 acres on the vacant land that used to be an orange grove on the south side of Center St. between the elementary school and U P Railroad tracks and Spring St.

that was built in 1890. Changing the zoning was never brought before the Highgrove Municipal Advisory Council members or any other members of the Highgrove community but 61 other names and agencies received notice about the Highgrove Community Plan. Everyone but Highgrove had a part in preparing this plan! Even the city of Riverside opposed the Bixby plan in a letter dated March 21, 2011 from City Planning Director Ken Gutierrez. Another article can be found on our website: highgrovehappenings.net by looking at latest issues (Feb. 2009) titled: "Warehouses approved over objections of Highgrove residents.....Public Hearing delayed 5  $\frac{1}{2}$  hours".

Even today after this zone change was "Fast tracked" the same 40 acres and the 27 acres, divided by Spring St., continues to be 67 acres of vacant land. Since no construction started within the 2 year time limit, according to the Riverside County Planning dept., the permit process has to be started all over again if Bixby or a new owner wants to develop the land under the MSC zoning. This can also be seen on our website in the Oct., 2011 issue titled: "Fast Track" plan derailed but has nothing to do with trains!

Riverside County Fire Department received several reports just before 6:30 a.m. on Nov. 20, 2011 of an apartment on fire in the 400 block of Devener Street in Highgrove. CAL FIRE/Riverside County Firefighters, along with assistance by San Bernardino County Fire Department arrived to find a second-story unit of a four-plex well involved. Quick action by firefighters contained the fire just before 7:00 a.m. CAL FIRE Peace Officers arrested 28-year old Danny Cruz, who admitted to starting the fire that displaced three families. Cruz was transported to Robert Presley Detention Center, where he was booked on two counts on Penal Code 451 (b), arson to an inhabited structure and one count on Penal Code 459, burglary. The Riverside County District Attorney's Office will be handling the case.

on the south, was changed by the Riverside County Board of Supervisors from IP to MSC on Jan. 13, 2009 over the written and verbal objections of the Highgrove MAC. This zone change also included Bixby's adjacent 27 acres of vacant land on the south side of Spring Street. Highgrove residents objected to these changes because we did not want warehouses to divide our community in half and warehouses were (and still are) inappropriate between the elementary school and the historical Highgrove Methodist Church

#### Highgrove Plan cont. from P. 1

Plans for any new construction should be presented to the Highgrove MAC at a public meeting before involving any other agencies outside of Highgrove. Meanwhile the Highgrove Community Plan needs to be re-evaluated as to the wants and needs of the people who live in the Highgrove community.

#### (2) Metrolink Station

Another change since 1999 is the acquisition of the property next to the BNSF main line at Highgrove by the Riverside County Transportation Commission. This property was purchased recently to connect the Perris Valley Line track to the BNSF track but it could also be used for a Metrolink station. Again I refer you to our website and an article on P. 9 of last month's issue titled: "Facts you should know about Metrolink Station location". Similar articles were published in the Grand Terrace City News, Loma Linda City News, Colton City News and Colton Courier and we thank them for their support. Unfortunately as of this writing the Press Enterprise has declined to print the information that was written exclusively for their newspaper. (3) Spring Mountain Ranch

We all have known about the new homes that are planned in the Spring Mountain Ranch area but the difference between the Highgrove Community Plan in 1999 and 2011, is that everything is ready for building the Spring Mountain Ranch homes

but the economy has taken its toll on this project. Nonetheless, the infrastructure is ready and there has already been \$250 million dollars invested before any new homes are built. This project sits ready for a home builder when it will be profitable because all that is needed is to skin the tumbleweeds off the pads and start construction. When will that happen? I wish I knew because that ole word "economy" is the major aspect of when these homes get started. You can be assured that with all of the money, time, and effort that have gone into this project over the last 10 years, I don't think they are going to re-plant this area with orange trees!

#### (4) Re-name streets before construction starts

When RWR homes, the builder for the Spring Mountain Ranch homes, bought the property from The Shopoff Group, RWR homes chose street names that the Highgrove MAC opposed due to future confusion caused by selecting different names on the east side of Center St. and Spring Street. Center St. east of Mt. Vernon was put on their map as "Old Highgrove Trail". The MAC has asked Riverside County to change the name to East Center St. instead, similar to Main St. that is known as East Main St. on the east side of Mt. Vernon Avenue. The MAC has also asked for Spring St. east of Mt. Vernon to be re-named East Spring St. instead of Blue Mountain Drive. The

sign on Mt. Vernon presently points westward to Spring St. and eastward to Blue Mountain Drive but there is no road or houses east of Mt. Vernon Ave. on Spring Street.

Center St. is a known exit from the I-215 freeway and Mt. Vernon Ave. is the dividing line between the east and west designations. Everything west of Mt. Vernon Ave. is now known as west Center Street. Center St. and Spring St. should remain the same name and the east/west designation line should continue to be Mt. Vernon just like it is on Main Street. Now is the proper time to change the names of these streets so that future motorists can find the new addresses.

#### (5) Pigeon Pass Corridor

The Pigeon Pass Corridor is another plan that is in the process of consideration that needs further examination by the residents of Highgrove, Grand Terrace and Riverside. There is a proposal to build a road from the top of Pigeon Pass along the ridge behind the old Highgrove landfill and connect to Main St. or Center Street. Other connections to Spring St. or Palmyrita Ave. have also been suggested by Highgrove and Grand Terrace residents.

#### (6) Grand Terrace High School

The new high school on the north side of Main St. is set to open next year. This school is directly across the street from the northern boundary of Highgrove and is another sample of why Highgrove needs a new community plan. This school will bring new drivers and additional traffic to our local residential surface streets. Riverside County has been working with the Highgrove MAC and Highgrove residents on how to accommodate this impact on our community.

(7) First Sewer Line in Highgrove Highgrove now has its first sewer line that begins at Center St. and Michigan Ave. by the new Highgrove Library and proceeds westward toward the I-215 freeway then turns south along East La Cadena Dr. and connects to Riverside's sewer system near Palmyrita Avenue. At the Highgrove MAC meeting on

Nov. 30, 2011, the MAC approved asking the authorities for a new Highgrove Community Plan.

#### **Riverside County's "College of Foreign Trade" A Huge Success...**



The Riverside County Board of Supervisors and the Economic Development Agency Office of Foreign Trade hosted the "Riverside County College of Foreign Trade" on November 7, 2011 at the **Riverside County Administration** Center. The event is the first in a series of seminars focused around educating local business representatives and government officials about the procedures involved and benefits accrued from establishing or improving overseas trade practices in any of the four foreign trade zones located throughout Riverside County.

Speaking at the event were numerous federal officials involved in varying aspects of the overseas market, including the Deputy Assistant Secretary of the United States Department of Commerce, Holly Vineyard, and Richard Swanson, Regional Director of the United States Department of Commerce. Both federal officials detailed the economic benefits Riverside County has received due to its inclusion of foreign trade zones, and encouraged other manufacturers throughout the region to utilize this incredible resource. Holly Vineyard from the US Department of Commerce noted "California is a bellwether

state when it comes to exporting, and [Riverside County] in particular has taken a lot of strides and efforts to help its companies learn more how to export." With four foreign trade zones and a fifth in the works, Riverside County currently leads the nation as the most export-friendly region in America. The excellent location and availability of land make the area appealing for large manufacturers to set up shop, most recently welcoming the enormous LEED Certified Skechers distribution plant in Moreno Valley.

Also in attendance at the event were many representatives from local businesses, and service providers interested in developing their ability to conduct foreign trade. President and CEO of Paulson Manufacturing, Roy Paulson, commented on how fortunate these business leaders are to become 'students' of the College of Foreign Trade: "As I watched the different speakers come forth...I thought about the bumpy road I had to go through to learn this type of information, and here it is laid out on a silver platter for the other businesses in our county." The inclusion of four foreign trade zones has incredibly benefited Riverside County's residents. John Tavaglione of the Riverside County Board of Supervisors credits foreign trade zones as being "really important in Riverside County in that 10% of our jobs come from the manufacturing of goods that are being exported, so that's about 90 thousand jobs, very significant."

While conducting foreign trade may appear to be a daunting task for most small businesses, David Josephson of the Export-Import Bank spoke on the procedures and criteria required with garnering foreign direct investment for local



businesses-an alternative method to securing financing and insurance when individuals directly involved are unwilling to accept the credit risk of international business. Quelling fears and offering resources for manufacturing employers to utilize in exporting is a top priority of the seminars, as Tavaglione observes despite the fact that "the region has a high unemployment rate, manufacturing continues to grow."

On top of all the information shared, Riverside County's "College of Foreign Trade" offers incredible networking opportunities for attendees. Foreign Trade Commissioner for the Riverside County Economic Development Agency, Tom Freeman recognizes the seminar as "the first time we've been able to bring leaders in the business community and

local government together to educate them about not only the importance of foreign trade, but how they can do a better job of knowing how to use all the tools that are available from the federal government, the county, banking institutions, EB-5 centers, and our foreign trade zones." Surely Riverside County's economic success will reverberate throughout California and other areas will follow the lead of the "most foreign trade zone-friendly county in the United States."

## Choo-Choo Chuga-Chuga It's No. 844

#### *By Melanie R. Zimmermann* **Did you feel it steam into San Bernardino?**

David and I went to see the Steam Locomotive No. 844 that is the last steam locomotive built for Union Pacific Railroad. It was delivered in 1944. A high speed passenger engine, it pulled such widely known train as the Overland Limited, Los Angeles Limited, Portland Rose and Challenger.

When diesel took over all passenger train duties, No. 844 was placed in freight service in Nebraska from 1957 to 1959. It was saved from being scrapped in 1960, and held for special service.

The engine has run hundreds of thousands of miles as Union Pacific's ambassador of goodwill. It has made appearances at Expo'74 in Spokane, the 1981 opening of the California State Railroads Museum in Sacramento, the 1984 World's Fair in New Orleans and the 50th Anniversary Celebration of Los Angeles Union Station in 1989.

Many people know the engine as No. 8444 to distinguish it from a diesel numbered in the 800 series.

The steam engine regained its rightful number in June 1989, after the diesel was retired.

Hailed as Union Pacific's "Living Legend", the engine is widely know among railroad enthusiasts for its excursion runs, especially over Union Pacific's fabled crossing of Sherman Hill between Cheyenne and Laramie, Wyoming.

The event delivered messages for train safety, literature, train whistles, engineer hats and a gift shop. Also there were many nice knowledgeable staff available to answer questions.

The photo above shows the north side of the warehouses along Citrus St. near the southern boundary of Highgrove. There are a total of 62 doors like these at the rear of the 2 large warehouses on Citrus St. between the Perris Valley Line railroad track and Iowa Avenue. One of these warehouses is 125,835 total sq. ft. and the other one is 66,599 sq. ft. and both have available signs posted along Citrus Street. These are just 2 of the buildings on the north side of Citrus St. but there are more warehouses on the south side of Citrus St. that are also available. If you want to see more "available" warehouses just drive up Palmyrita Ave. or Columbia Ave. and look at all of the existing warehouses that are "available".

The dividing line between the Riverside city limits and Highgrove is along the arroyo except for a few homes and one business south of the arroyo and east of the single railroad track known as the Perris Valley Line track.

The north side of the arroyo is in Highgrove except for the warehouses on the north side of Citrus St. and the 17.22 acres north of the arroyo that RCTC just bought to connect the Perris Valley Line railroad track to the BNSF main track.

The march of the warehouses should be stopped at the arroyo instead of allowing them to invade Highgrove with large warehouses that will cut our community right in half!
