



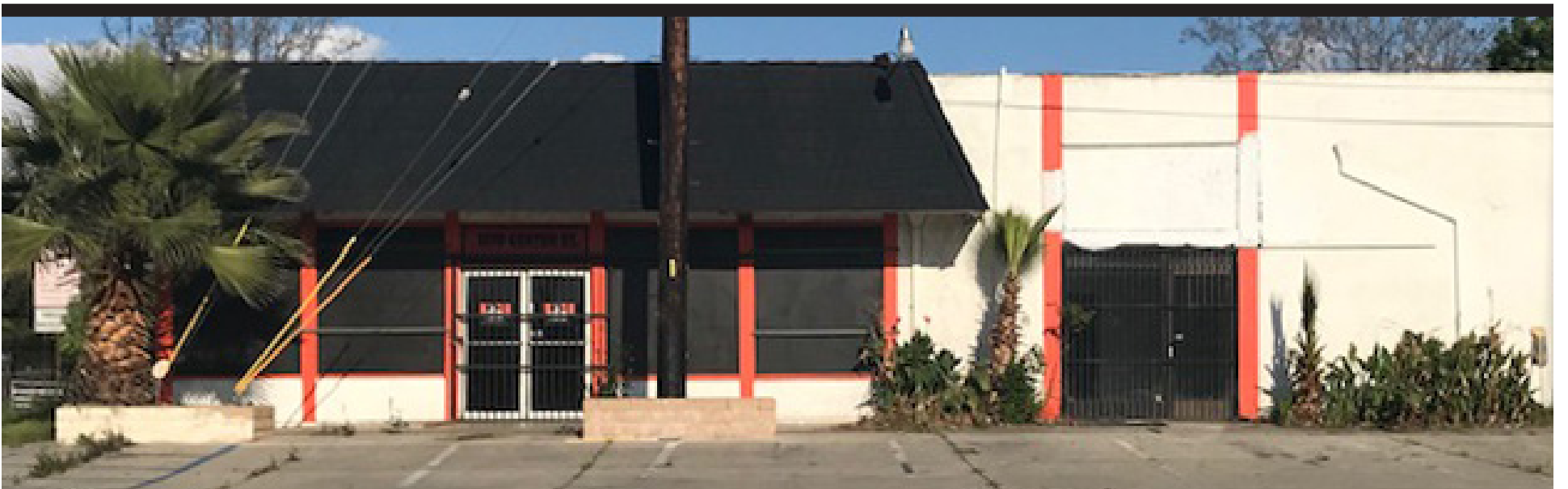

Pot Shops trying to invade Highgrove Again! Second try at the same location!

On May 19, 2020 the Riverside County Board of Supervisors rejected a plan to reduce the distance between pot shops from 1,000 feet to 250 feet. Now for the second time, the applicant is asking that the distance between pot shops be reduced from the present 1,000 feet to 290 feet instead of 250 feet.

The location in question is on the south east corner of Center St. and Iowa Ave. in Highgrove.

The last time, residents from Highgrove waited 7 hours to speak against reducing the distance to 250 feet but now the applicant has returned with a slight variation of their original proposal.

Advantage:

Under Supervisor Ashley's jurisdiction, developers or companys who wanted to make significant changes in Highgrove were asked to go to a Highgrove Municipal Advisory Council meeting and tell residents what they wanted to do in our community. This was before they went to the Planning Department and it gave Highgrove residents first hand knowledge of what they wanted to do in our neighborhoods.

This time Highgrove faces more hurdles due to the following circumstances:

Disadvantages:

1. When the first pot shop in Highgrove was approved at 240 Iowa Ave., the applicant went directly to the Planning Department but never went to any MAC meetings to tell Highgrove residents that they wanted to open a marijuana store in Highgrove. Then on on Dec. 10, 2019 the Board of Supervisors approved the first Pot Shop at 240 Iowa Ave. but this store has not opened yet!

2. Now, for the second time the applicant is going back to the Planning Department in an effort to open another pot shop only a few feet from the first one. The ordinance requires that there has to be 1,000 feet between pot shops but the applicant wanted the distance to be shortened to only 250 feet between stores to open another marijuana store on the south east corner of Center an Iowa.

3. Then on May 19, 2020 the Board of Supervisors denied reducing the distance to 250 feet and the distance remained at 1,000 feet.

4. The July 1, 2020 Public Hearing will be another attempt to open a pot shop that has already been turned down at the corner of Center and Iowa but here is why this is so important:

At the May 19, 2020 meeting Supervisor Spiegel, who is the Supervisor for Highgrove, stated that if shortning the distance to 250 feet only applied to Highgrove, she would be in favor of it but since the 250 foot distance was going to apply to the entire county, she voted against reducing the distance!

In other words she was against it for the rest of the county but it was OK for the people of Highgrove!

Remember, the Highgrove people have not been asked how the feel about pot shops in Highgrove and this subject has never been discussed at any of Highgrove's public MAC meetings.

5. Now the applicant is going back to the planning department on July 1, 2020 to try to get the distance between pot shops changed from **250** feet apart that was rejected, to **290** feet apart. It appears that by extending the distance another 40 feet they hope to get their property approved for another pot shop in Highgrove.

According to Tim Wheeler of the Planning Department the 2nd application to reduce the distance from 1,000 feet to 290 feet will also apply to all of Riverside County just like

the first application that was denied.

6. Prior to the planning meeting on May 19, 2020, the Riverside County Planning Department determined that the previous project will not have a significant effect on the environment and has recommended adoption of a negative declaration.

The meeting on July 1, 2020 will be conducted two different ways, by teleconference, and at the place of the hearing, which is 9:00 am at 4080 Lemon St. in Riverside. Public access to the meeting location will be allowed but limited to comply with the Executive Order.

Information on how to participate in the hearing via telephone is available on the Planning Department website at: **planning.rctlma.org**. Just follow the instructions on how to voice your opinion via teleconferencing. The agenda item is # 4.1. 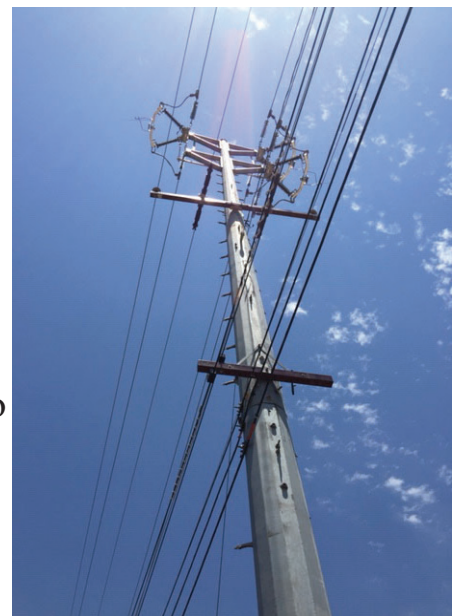

What happened to 10 ½ years of Highgrove's Tax money?

Follow the money!

At a public hearing on March 12, 1991, the minutes show that Highgrove residents **"voted for the extra police protection, and to expand the CSA 126 to include park and recreation services."** (CSA 126 minutes Feb. 12, 1992)

And in 1992 the Sheriff Dept., Riverside County, and the CSA 126 Advisory Board agreed to a \$10.00 per month parcel property tax for a Sheriff Deputy assigned exclusively to Highgrove. It was agreed that \$7.96 of the monthly fee would go toward Sheriff and \$ 2.04 toward the future Park and Recreation development fund. (CSA 126 minutes dated Feb. 12, 1992)

Ballots were mailed to Highgrove property owners by Riverside County Administration, Highgrove property owners voted and approved the assessment, and \$120.00 was added to Highgrove property tax bills to pay for Highgrove's Deputy Sheriff. The ballot simply stated: **"Continue present level of police protection with no increase of parcel fee"** YES or No

Then due to proposition 218 in 1997, Highgrove was required to vote again on the Highgrove Deputy Sheriff's position.

But prior to the ballot being mailed out to the voters, Riverside County Council printed an **"Impartial Analysis"** that stated what would happen if the measure passed. Part of the "Impartial Analysis" states: **"The tax will be retained in the CSA 126 fund to be used only for purposes of continuing Extended Sheriff, and Park & Recreation services and improvements. The tax cannot be increased except for a 2/3 vote of the electorate."**

Here is a copy of the 1997 ballot that was approved by 75.8% of the voters.

Then on April 12, 2016, as Chairman of the Highgrove Municipal Advisory Council, I discovered that **"Landscaping"** had been added to the tax bill designation without a vote of the Highgrove property owners. (Ref: July 2016 issue of Highgrove Happenings Newspaper page 6 dated April 12, 2016) I went to the County Tax collector's and Auditor's offices and found out CSA 126E had been changed to CSA 126 PARK & REC LNDSCPE without a vote. Compare the difference between these two following tax years:

FY July 1, 2014 to FY June 30, 2015: **CSA 126 E** was changed to: FY July 1, 2015 to FY June 30, 2016: **CSA 126, PARK & REC LNDSCPE**

Beyond Highgrove's borders!

I usually don't comment about articles beyond our borders but as an American I am concerned about what is happening to our country.

The murder of George Floyd has taken a back seat and missed by radicals who are trying to overthrow our government!

Where are the protests and demonstrations for these law enforcement officers and the other officers who have been killed or injured? Don't they deserve justice too?

In a television interview on June 14, 2020 the black attorney for the George Floyd family, Attorney Benjamin Crump stated: **"We don't want it to be two justice systems in America-one for black America and one for white America. What we want is equal justice for the United States of America and the only way we can heal this country is by working together"** He also said that **"defunding" the police did not come from the Floyd family.**

As the violence continues to spread across America and other countries, aren't you glad you live in the small community of Highgrove instead living in a large city?

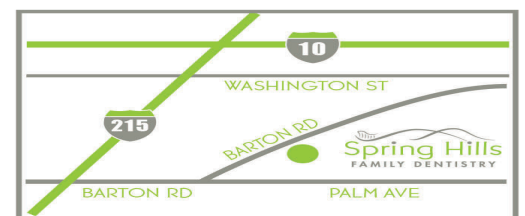

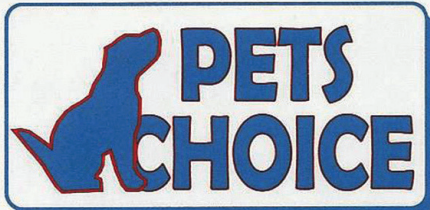

Riverside County has been in financial trouble for a long time but members of the Highgrove community are entitled to know where all of their special assessment tax money went that was collected since the Highgrove Sheriff Deputy was eliminated on Dec. 30, 2009.

Riverside County received property taxes from us for a service we have not had for over 10 ½ years but today we are still paying for a Sheriff Deputy that was eliminated without another ballot.

If the assessment was only for two purposes as stated in the “Impartial Analysis” and the Sheriff costs were eliminated, the money collected for the Sheriff should still be in the CSA 126 account if it was properly **“Retained”** as provided for prior to the vote in 1997.

Highgrove Community Park

Until June 1, 2019 Highgrove only had one unlighted five-acre park and for several years there have been no little league games or other organized sports in this park resulting in the snack bar not been used for several years. Highgrove Community Park is primarily used as a walking track with no organized sports available.

Riverside County \$100 million in the hole?

The June 2020 report from Riverside County Supervisor Kevin Jeffries states that the Riverside County CEO, George Johnson has proposed a new budget that anticipates \$100+ million in revenue reductions and has asked each department to cut between 5 (mostly public service agencies) and 10 (everyone else) percent of their budget, with the possibility of an additional 5% later. Those being asked by the CEO to trim more than a million dollars from their budget are the **Sheriff Dept.-\$16.7 million dollars.**

Sheriff Chad Bianco asked for \$366 million for his budget to run the Sheriff's Department but was given \$351 million by the Board of Supervisors on Tuesday June 23, which is \$15 million dollars less than he asked for.

Summary: When the Sheriff Dept. cuts their budget, that means fewer deputies will be available to un-incorporated communities such as Highgrove. Back in 1991, Highgrove agreed to pay extra for their own deputy due to the poor response time to get a deputy to our community from Jurupa Valley. Unfortunately, future response times to Highgrove may be going back to the 1991 response rate.

Is it possible that money from Highgrove's CSA 126 account was used to pay for landscaping in Spring Mountain Ranch? And if the CSA 126 funds were not used in Spring Mountain Ranch, then where did the 10 ½ years of tax money go that was collected by Riverside County? Were the funds actually **"retained"** in the CSA 126 account as instructed after the Sheriff was eliminated? And how much of this money was actually spent on the five-acre park during the last 10 ½ years?

Highgrove property owners are entitled to know where every dollar of their special assessment money has gone after the sheriff was eliminated because this special assessment money was only supposed to be used for two specific purposes and by now you should know what they were!

Three retired railroaders unite to preserve historical railroad event in San Bernardino!

In the early 90's the Santa Fe railroad decided to eliminate the diesel repair shops, in San Bernardino, that were over 100 years old at that time. These giant warehouse repair shops rebuilt the diesel engines and everything related to the engines that keep the trains rolling.

During this period of time, I was working in the San Bernardino Railroad Yard as a Switchman and I had a camera with me to take pictures of the dismantling of this giant facility. The Santa Fe shops were being removed to make way for a giant piggy back/container yard that is now located just east of the Mt. Vernon Ave. overpass in San Bernardino and north of the old Santa Fe Depot that was opened and dedicated back on July 15, 1918.

On June 7, 2020, I visited my friend John Salvini, who I worked with for many years. He used to maintain the diesel engines at San Bernardino. John also worked in the Santa Fe shops for many

years and I gave him 2 large books of pictures I took years ago. He is going to identify and label the pictures to identify each photo.

After visiting with John Salvini, I went to my friend Mike Croy's in Grand Terrace and Mike said he will be able to put my pictures with Salvini's descriptions onto the Santa Fe web site so they can be shared with other interested parties. This three-person venture is just starting but we will keep you posted as it progresses. I have hundreds of photos and with their help we can preserve these one of a kind pictures for everyone to enjoy.

"I never considered a difference of opinion in politics, in religion, in philosophy, as a cause for withdrawing from a friend." ~ Thomas Jefferson

Here's a little Independence Day trivia: Thomas Jefferson AND John Adams both died hours apart on the same day- on July 4th, 1826, the 50th anniversary of the vote for independence. Each mentioned the other in their last breath, thinking the other was living past them. The Declaration of Independence was not signed on July 4th, although it makes great drama in the movies. The official parchment document was signed August 2, 1776. On the 4th of July the wording written by Thomas Jefferson was approved and sent to John Dunlap, a Philadelphia printer. These 18th century press releases, known now as "Dunlap Broadside", were distributed to colony newspapers, officials, and commanders of the Continental troops. King George III was sent one as well; he was totally unimpressed. It was published in British newspapers in mid-August and in other countries throughout the rest of the year.

There is only one document that was signed by the states' delegates. With the upheaval of the Revolutionary War, capitals and cities being burned, it's remarkable that the original remained intact and survived to this day. Any other copies in the hands of museums and collectors are Dunlap Broadside. Out of the few hundred that were printed, only 26 are known to survive. (Note: Signer Lyman Hall, MD of Georgia is a distant relative of our family on my mother's side.) There IS something written on the back of the original Declaration of Independence. Not in invisible ink either nor is it a treasure map. "written upside-down across the bottom of the signed document: 'Original Declaration of Independence dated 4th July 1776.' No one knows who exactly wrote this or when, but during the Revolutionary War years the parchment was frequently rolled up for transport. It's thought that the text was added as a label." *

During WWII the document was stored at Ft. Knox.

As we all know, the southern states' condition to support independence hinged on the issue of slavery. While some of our Founding Fathers were slave owners, they still wanted to include the abolishment of slavery. The wording in the Preamble: ***"We hold these truths to be self-evident, that all men are created equal, that they are endowed by their Creator with certain unalienable Rights, that among these are Life, Liberty and the pursuit of Happiness."***— "is one of the most quoted, most contentious lines Thomas Jefferson wrote. Ratified in 1776, it took another hundred-fifty plus years for that "unalienable right" to be extended to ALL people, including women and people of color. Even today, voting isn't as accessible as it should be. Shame!

Legal historian John Phillip Reid opined that the Declaration is not a political philosophical tract about natural rights. It is a legal document that indicted King George III and legitimized the resistance of the colonists and legitimized the the legal sovereignty of the United States to the rest of the world. It was a bold statement and it was the first major binding legal document of the newly born nation.

This Independence Day will be like no other. It's not the carefree Summer holiday we've come to enjoy and expect. Gatherings are severely limited, many cities are forgoing fireworks, and there's political unrest, the likes of which we've not seen for many generations. I've been appalled by the divisions that keep occurring. Some are over serious issues and differences of opinion. Some are over things that shouldn't matter. Too often the differences are expressed with despicable behavior and words. The actions are based on emotions rather than critical thinking and common sense. Social media has served to shine a light on abhorrent actions by all types and occupations of persons thus galvanizing people to demand changes. These changes, while widely supported, will come slowly as there is considerable resistance. Emotions are running high. Common sense is in short supply. Like toilet paper and coins.

No one I know is happy to flip the calendar to July. It's with great trepidation we move forward through this year like no other. We just want to get over 2020 with the hope 2021 will be better. Focus on the big picture- we have a remarkable country that has been around 244 years. We are struggling with some serious make-or-break issues. With cool heads and a commitment to do what is right for the whole country's future, we can get through this. 

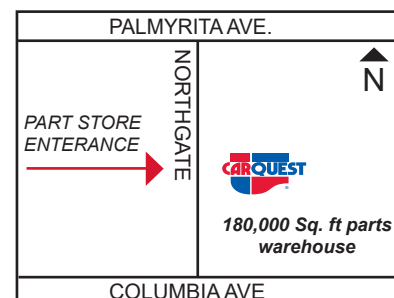
