SAVE THE TRUJILLO ADOBE!



On March 31, 2018, residents from the west side of the freeway who are concerned about a new giant 308,000 Sq. Ft. Warehouse being built near the historical Trujillo Adobe, congregated at the site of the landmark to show their objection to the large warehouse. There were a lot of people who

had written signs who are shown standing and sitting in front of the Trujillo building. Another protective building has been built over the original adobe building that was built in 1862 to prevent any further erosion from rain, wind or vandalism. The fragile adobe inside is not able to be moved due to its age and

would probably crumble if moved. But local residents want to preserve this historical landmark which is City of Riverside Landmark # 130 and Riverside County landmark # 009.

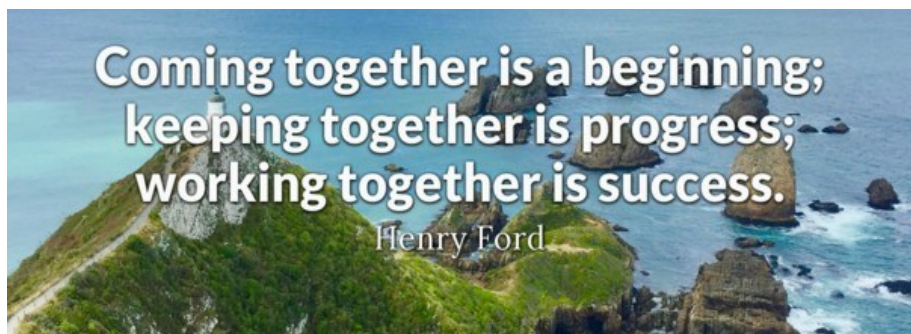

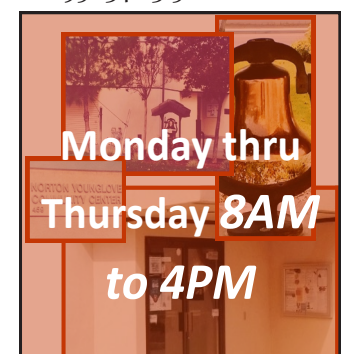

PROTECTING HIGHGROVE HISTORICAL PAPERS!



It is important to look to the future but to others it may also be important to see where we have been and what happened yesterday and beyond. Past issues of your local newspaper are available at the Highgrove library and contain information about Highgrove that goes back many years. To those of you who are new residents it will enable you to see some of the local landmarks that have disappeared before you moved to Highgrove or learn something about Highgrove's past that you may not know. Each month for 23 years, I have gathered information for the Highgrove Happenings Newspaper but many things may not actually get into the paper. Over the years I have kept the excess information that I used for researching facts to print in our paper but unfortunately I ran out of room to store the boxes.

When I heard that there was an empty container available that belonged to Highgrove, I thought this would be an ideal place to store these Highgrove items. I had 23 boxes (one box for each of the last 23 years) that I donated to Highgrove for future historical references and I took them to the container for safe storage. Also among the items I took to the container for safekeeping, was a brown suitcase that was given to me by CSA 126 Chairman Joe Barber in 1991 when I was Vice-Chairman of CSA 126. The suitcase contained minutes of previous CSA 126 meetings before the Highgrove MAC was formed. But on Feb. 22, 2017, while talking to Becky Luther prior to a meeting at Supervisor Tavaglione's office, Becky raised the issue that if Riverside County wanted to use the container for other purposes or move it to another location,

that possibly the contents would be thrown away. This concerned me because the container belongs to Highgrove and not Riverside County. Then, near the end of the Public Hearing on April 11, 2017, Supervisor Tavaglione appointed Highgrove resident Becky Luther as his contact person for Highgrove! This concerned me because the locks on the container have been changed and the brown suitcase inside the container contains important information that may be detrimental to Supervisor Tavaglione and Riverside County, and Becky is the only one who has a key to the container. When I asked Becky for the brown suitcase, she refused to give it to me saying it belongs to Riverside County. And since Becky has the only key to the container, I wondered if she, as Supervisor Tavaglione's friend and appointee, was keeping the suitcase under her control to protect the county. I originally thought this would be a "safe" place for storing important information about Highgrove but maybe I was wrong! I already have some of the information that is contained in the suitcase but another look at these items is important due to recent developments about the Sheriff and our CSA 126 fund because there may be additional documents that will help the Highgrove people in order to resolve the issue about paying for

Highgrove's own Deputy Sheriff that we have not had for the last 8 years. The suitcase is where I found the breakdown in 1992 of the \$10.00 per month assessment that stipulated that \$7.96 would go for Sheriff and \$ 2.04 for park & recreation. I did not want a key but I thought someone else, in addition to Becky, should have a key in order to know who has access to the container so these historical items can be saved. The container is an ideal place to store these items but in order to protect them I decided to remove them from the container and find a place that would be less accessible to Supervisor Tavaglione's appointee. Becky agreed to meet me at the container so on April 12, 2018, I went to the container to pick up the boxes and the suitcase but the 23 boxes had already been removed from the container and were on carts inside the community center. I was allowed to pick up the 23 boxes but the brown suitcase was not among the items I was allowed to take. I loaded the 23 boxes of excess Highgrove Happenings research papers into my truck and left. Two days later Becky opened the container doors and allowed me to look inside to see the brown suitcase but I did not go inside the container to see if there were any contents in the suitcase. I am currently looking for a safe place to store items that can be used for a future Highgrove museum.

ITEMS WANTED FOR HIGHGROVE MUSEUM!

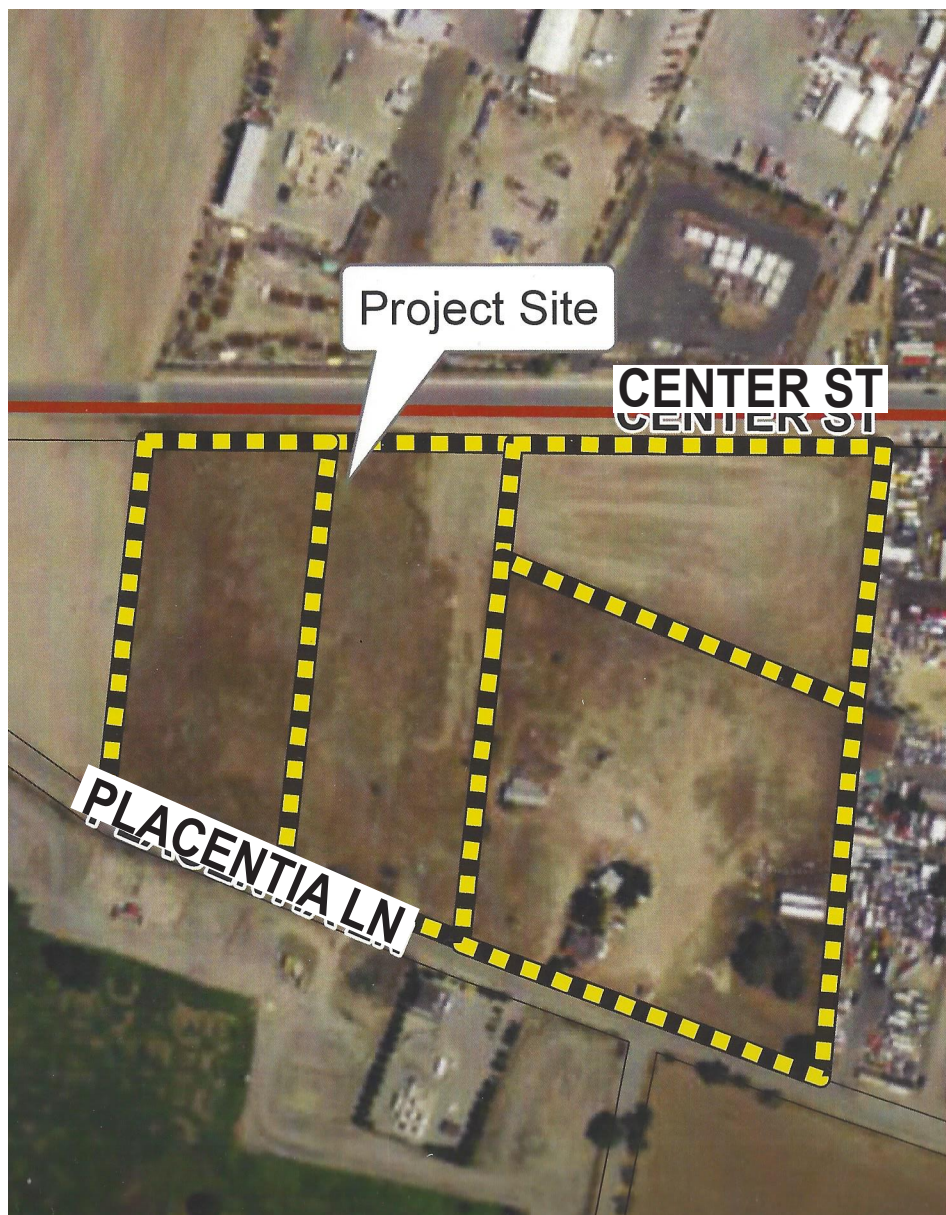
In order for future generations to see about Highgrove's rich historic past with the citrus industry and the railroad that has been going through town forever, I am collecting items for a future Highgrove museum. I have items I will donate such as the hand-made model of the Highgrove Depot that was made by the late Santa Fe Agent Bruce Easton and other small items but I am looking for a Smudge pot, a brass door that was used in the Highgrove Post Office across from the church on Center St., and any other items that may be in your attic. I am also looking for anything from the Highgrove Bank that flourished in the 30s or something about Judge Garner who was the banker. I have photographs from Highgrove's early days including pictures of the Handcock Brick Company, the

water tower by Lily cup on Citrus Street, the giant propane Bar-B-Q tank that used to sit on the west side of the freeway by the freeway entrance, and other photographs. If you have not seen the citrus label collection at the Norton Younglove Community Center you may want to take a look at the display put together by Denis Kidd of 92 citrus labels that were brands packed in Highgrove by the various packing houses that are now gone. Denis also provided the artwork for the citrus labels that are at the entrance of the Highgrove Library. I also have a photo of when the orange trees were planted years ago and later when there were several packing houses. Highgrove has only one packing house left on Center Street.

So take a look around and see if you have something that will document our history. It may not seem important but give me a call anyway!

308,000 SQ. FT. WAREHOUSE APPROVED BY RIVERSIDE PLANNING COMMISSION IN SPITE OF LOCAL RESIDENT'S OBJECTIONS



An Appeal on April 5, 2018 to stop the warehouse on the south side of Center St. between North Orange St. and Placentia was denied and the warehouse was approved anyway by a 4 to 3 vote in spite of opposition from surrounding residents from the Springbrook Heritage Alliance which is concerned that the warehouse is too close to the historic 1862 Trujillo Adobe which is a designated historical location. Opponents are also asked to attend a Land Use

Committee Hearing on May 14, 2018 at Riverside City Hall, 3900 Mains St. in Riverside starting at 1:00 pm. This location is within the city limits of Riverside and contacting Mayor Bailey and the city council members is encouraged in addition to sending an article to the Press Enterprise. RE: CSA Highgrove Supplemental Law Enforcement Funding for FY15-16 and FY16-17


The Jurupa Valley Station has been funded over the last two fiscal years (FY15-16 and FY16-17) for Supplemental Law Enforcement for CSA Highgrove. Below is a summary of the funding received and utilized (spent) for each year:

FY15-16: We received \$25,000 in funding for the entire fiscal year. We began operations on July 10, 2015 and finished on June 24, 2016. We expended \$24,902.47 of the funds received leaving a small balance of \$97.53 unspent.

FY16-17: We received \$35,000 in funding for the entire fiscal year. We began operations on July 4, 2016. We have expended \$21,951.37 to date (including January 2017 operations). This leaves a balance remaining of \$13,048.63 to be expended before June 30, 2017.

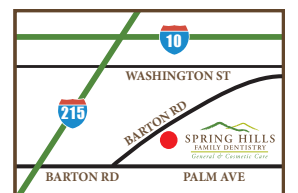

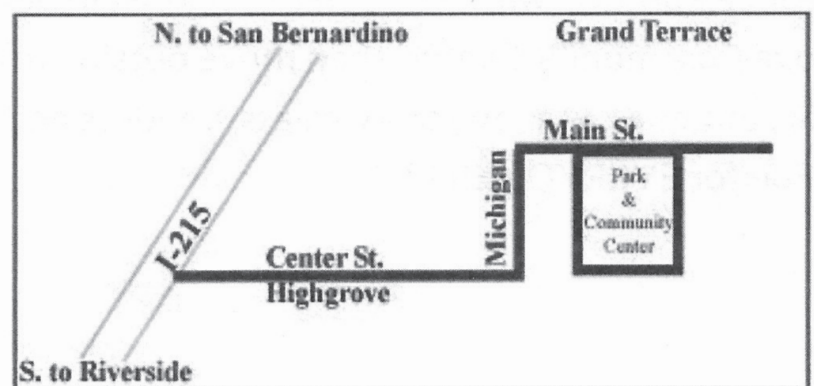

A FREE PRESS IN PERIL

On April 15 the Press Enterprise ran 5 full pages about the changes in journalism.

Here a few random excerpts taken from some of the journalists who contributed to the Press Enterprise article.

Frank Pine: "Most newspapers are, in fact, profitable. They just won't stay that way without continually cutting expenses to keep ahead of dwindling revenue streams. Today's digital economy has made that very clear as internet giants such as Google and Facebook dominate the digital ad space based on their ability to deliver content and advertising much more quickly and efficiently than legacy news media did or could." "As American journalism declines, corruption blooms."

Doug Saunders: "Real journalism requires you to go where the story is, to see it with your own eyes and to report on it as it happens." "Unlike all the fake news floating around on social media, real news is hard to come by." "I'm proud of my former colleagues who are still hard at work bringing local news home informing their communities of critical events in their lives."

Toni Sciacqua: "Pre internet newspapers made big profits because they owned the distribution system. They invested in big, expensive presses to print ads. The ads were surrounded by news stories, reported by journalists following professional guidelines and selected by editors, which gave readers some incentive to go look through

the paper. We paid the cute kid on the bike to bring the paper to your doorstep every day. You read it, so you knew what was going on in the world and made smarter decisions. It was a virtuous cycle-good for business, good for democracy. Now, instead of doorstep, most people get their news on a smartphone."


Steven Greenhut: "Printed newspapers first emerged in the 1600s. The modern newspaper industry took off in the mid 1800s as newfangled printing presses allowed the distribution of cheap printed copies. In my neighborhood growing up, virtually every family had a paper delivered daily to the door".

Samantha Gowen: "As brick and mortar businesses have leapfrogged to new technology or bottomed out

all together, the pages of local papers have thinned and hometown coverage has shifted like the sand on Southern California beaches".

Scott Kaufman and Sal Rodriguez: "One of the core responsibilities of journalists and newspapers is to hold government at all levels accountable to the public. Journalist are the key to filling that void. Keeping an eye on government, scrutinizing the words and policies of politicians and governments and presenting relevant information to the public so informed decisions can be made is a key responsibility of local newspapers."

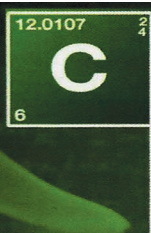

We were there for four days and three nights from April 3-6. Around here we don't necessarily see YMCA's as a big part of life, but the pastor of the church where we stayed assured us that this YMCA is a central part of the community of Katy.

This was a great experience and it was very rewarding to be able to help these people and make a real difference in their lives.

Senate Bill S. 2360 would require a crew of two on all freight trains

Senator Diane Feinstein is a co-sponsor of S. 2360, the Safe Freight Act, which would require a crew of two on all freight trains. If S. 2360 is signed into law it will:

- Prohibit a railroad from using single person operations.
- All freight trains would be required to have an engineer and a conductor.
- Maintain the safety that two person crews provide to communities that trains travel through.
- Protect members of SMART (Sheet Metal, Air, Rail, & Transportation) from the dangerous practice of single and even no person train operations.

Complaints received!

We have been receiving complaints about quality of life issues in Highgrove. People are concerned that there are now 5 marijuana shops in our community, graffiti has increased, and tributes to people who have passes on, or have health issues, are displayed along our streets.

We respectfully understand the friends and relatives feelings about the loss of a loved one but one of the displays is at Highgrove's main intersection at Center and Iowa, and another one is on Main St. that has been up since September of 2017 that seems to keep growing larger every day.

Each person needs to mourn the loss of a loved one but sometimes that person or persons may never get over their loss. 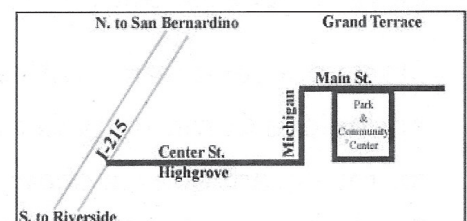

IS THERE A DIFFERENCE BETWEEN LYING AT A PUBLIC HEARING OR LYING WHILE UNDER OATH?

On Nov. 14, 2017, I testified under oath before the Grand Jury in regard to my request for a Grand Jury Investigation about Highgrove's CSA 126 funds and Highgrove's Sheriff Deputy that was eliminated without notice. I will not print these questions at this time because I do not know if the Grand Jury will call Supervisor Tavaglione to testify under oath.

The subject matter involves Supervisor Tavaglione stating at the Public Hearing that Highgrove MAC Chairman Barnett was going to use MAC funds to sue Riverside County.

But Supervisor Tavaglione knows that none of the MAC Volunteers have ever had access to any MAC

funds. Supervisor Tavaglione made false statements at the Public Hearing because he thought that would give him a reason to disband the entire Highgrove MAC even though California State Government code # 31010 had not been violated.

California State Code # 31010 is about the Formation/Operation of Municipal Advisory Councils and Community Councils.

Item h. states:

Duration: *"Should it be determined that the CC/MAC is no longer functioning consistent with Government Code Section 31010, the authority and procedures set forth in this policy or any subsequent adopted rules, resolutions, ordinances or laws, then a public hearing may be conducted by the Board to determine whether the CC/MAC should be dissolved. The Board, in its sole discretion, may dissolve the CC/MAC by resolution"*

But the Highgrove MAC was functioning consistent within Government Code Section 31010 and the only thing that Supervisor Tavaglione did not like was the fact

that Barnett as the Highgrove MAC Chairman, was asking too many questions about the CSA 126 funds and the Highgrove Sheriff that was eliminated 8 years ago that we are still paying for.

The Policy of California State Government Code Section 31010 allows for the creation of an advisory council within unincorporated territory for the purpose of advising the Board (Board of Supervisors) on matters including but not limited to, public health, safety, welfare, public works and planning.

But the Riverside County Board of Supervisors adopted another policy called A-51 that reads:

Existing MAC/CC Policies:

"In instances where existing by-laws or policies of MACS or CCs may be inconsistent with Board Policy A-51, Board Policy A-51 is deemed to take precedence."

So what happened to the California States Government Code 31010 that said the MAC could be dissolved if it was no longer functioning consistent with its policy? Was A-51 a way around the California

Governments State code? And was Supervisor Tavaglione justified in eliminating the entire Highgrove MAC after Chairman Barnett had already resigned? Was the entire Highgrove MAC's voice silenced because Barnett was asking too many questions about the CSA 126 funds and the Sheriff?

Supervisor Tavaglione needs to be put under oath and testify before the Grand Jury about Barnett using MAC funds to sue Riverside County because he lied when he said Barnett was going to use MAC funds to sue Riverside County.

Supervisor Tavaglione knows that MAC volunteers have never had access to any funds!

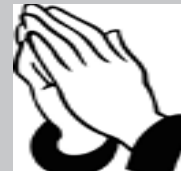

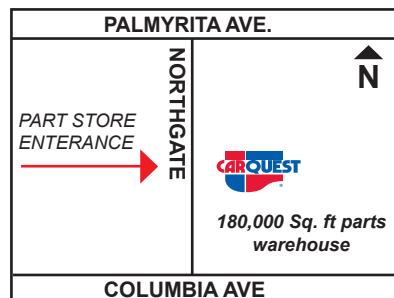
