## Local residents receive awards



Joe Morones, 4th from left received an award for volunteering in Highgrove. The awards were given out on April 16, 2009 at the 3rd Annual Molina Healthcare of California Community Champions Awards Dinner. The award is named after Molina Healthcare's physician founder Dr. C. David Molina.

Joe and his wife Francis have been married for 59 years. He worked at Caltrans for 18 years before retiring but now he spends many of his retirement hours helping others by volunteering at the community center in Highgrove. He is in charge of several free food distribution programs such as the "Brown Bag", "Rolling Cart", and "Commodities". These programs help feed seniors and families each week. Joe has volunteered for 14 years running the food programs and he says he puts in about 80 hours a month. We appreciate having people like Joe in our neighborhood and thank him for his dedication and helping other members of our community. He received a grant of \$1,000 and he has designated Family Service Association/ Norton Younglove Community Center to be the recipient of the grant. ## WHAT IS A MAC Highgrove

What is a MAC: Municipal Advisory Councils (MAC's) were formed by the direction of Supervisor Marion Ashley in order to bring government to the people. These meetings allow for community input and updates on projects happening in surrounding unincorporated areas of Riverside County. They serve as a forum to provide updates from various Riverside County departments and as a venue to take back topics of importance.

How it was created: The MAC's were created through establishing physical boundaries, legal descriptions, and appointing members from the community. These actions were then adopted by the Riverside County Board of Supervisors.

Who is on the Council: On the Highgrove MAC we have R. A. "Barney" Barnett, Mark Visyak, Kathleen Cochran, Don Earp, Denis Kidd, Debbie Pierce and Melanie Zimmermann.

What do they cover: The subjects include but are not limited to water, code enforcement, transportation, planning, economic development, redevelopment, parks/recreation, animal services, and public safety such as sheriff protection.

What has been covered/ milestones etc: Recently, Highgrove MAC has discussed the 88 unit apartment complex proposed near the new library site. We also discussed Highgrove Day, which is scheduled on May 9, 2009. In February we took a van tour to visit some of the various project sites in Highgrove.

What is on the next agenda: The next agenda topics will be a potential project by AW Property West and Work Force Home Builders.

When and where do they meet: The MAC meets on the fourth Wednesday of each month at the Norton Younglove Community Center, in Highgrove.

## Report from Highgrove Deputy

### Graffiti vandals caught!

Riverside County cleaned the Highgrove area of old graffiti on April 17, 2009. But later, during a stake out by the Highgrove Deputy Bryan Vig, three males were observed spray painting new graffiti in the canal. Two of the individuals were juveniles and were released to the parents. Charges filed were vandalism and possession of items, (spray paint) used to commit graffiti. The third suspect was an 18 year old adult named Jaime Sandoval. The adult legally purchased the cans of spray paint that day and used/provided them to the juveniles. Charges filed with the Riverside County District Attorney are: vandalism, providing juveniles with items (spray paint) to commit graffiti, and contributing to the delinquency of minors. The amount of damage is estimated at approximately \$600.00. Restitution was asked from the suspects and their legal guardians upon adjudication of the case.

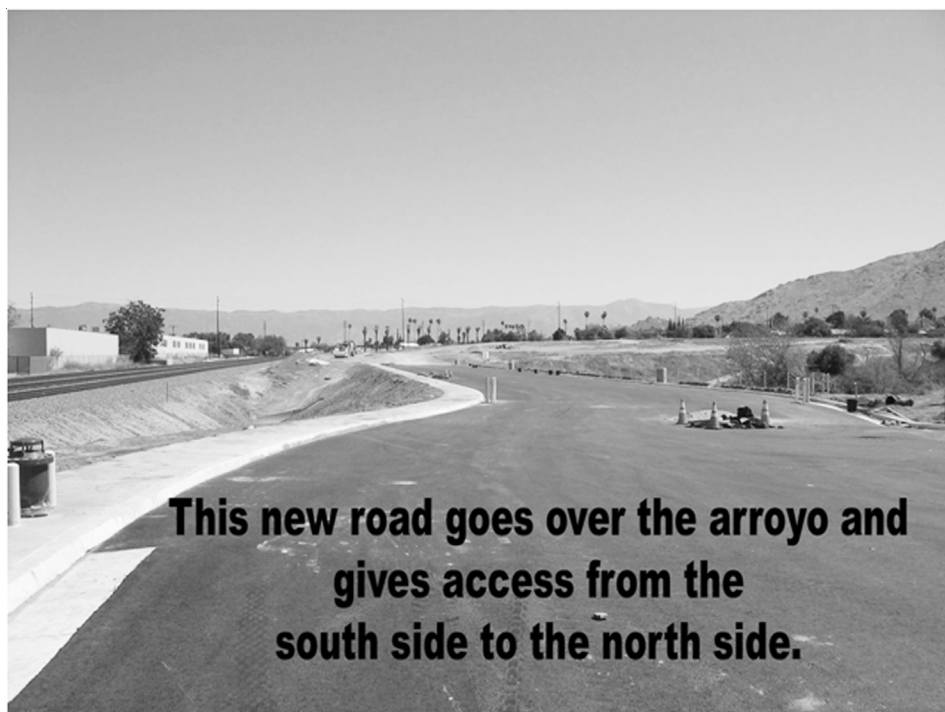

## Summer Youth Jobs programs receive \$9 million for jobs!

Riverside County Facilities Department, the Economic Development Agency, and the County Workforce Development Board received \$9 million dollars for Summer Youth Jobs programs from federal funds via the Workforce Investment Act. It is our desire to put 2,500 young men and women in summer jobs. Our Workforce Development Board, appointed by the Board of Supervisors, has already given its approval to the plan to put 2,500 young men and women in summer jobs and will be forwarding the plan to our Board of Supervisors for their review and action in short order. After the board takes action on the plan, funds will be immediately available for the Summer Youth Job program. Eligibility requirement and transparency standards for these funds have been established by federal authorities. Specific information on the hourly wage rate and program eligibility requirements will be detailed later.

## Developers seeking apartment complexes in Highgrove

Two different developers have been attending our MAC meetings to discuss and work with the council and community and explain what they want to build on the vacant land between Michigan Ave. and Garfield and Center St. and Spring Street.

Tony Mize of Workforce Homebuilders has approached the council in regard to building 88 units on 6.2 acres south of the new library that is planned near the corner of Center St. and Michigan Avenue.

And Kirk Wallace from A W Proper-

ties West has also attended our meetings in regard to building approximately 150 additional apartment units near the same location that is between Michigan Ave. and Garfield St. and Center St. and Spring Street. Both of these developers are interested in what the public concerns or interests are, and they are willing to listen to suggestions about the use of the vacant property.

The building was the former location where nearby residents could get a haircut, go shopping for groceries, get a TV repaired, or shop at the variety store. Maybe we should learn from this old concept since there is a lot more traffic now than there was back in the late 40's. We need a centralized location for shopping in Highgrove instead of having to spend our money in San Bernardino County!

## Firemen save house in structure fire!

Late Sat. night on April 25, 2009 Debra Fury and her 13 year old daughter were startled by someone banging on their door to get out because of a fire!

Luckily the fire started in the back of their property and the house is located on the front at 620 Prospect Avenue. Both she and her daughter were able to get out of the house but the fire destroyed a shed, work shop, green house and an overhead structure that covered an indoor swimming pool. Also destroyed was a covered sun room that extended from the back of the house but firemen were able to stop the flames before the actual house was damaged.

She is very grateful to the firemen who saved her house. Her 17 year old son was not at home at the time but he lost everything in the fire including a bicycle, motorcycle and new guitar. The flames lit up the nighttime sky that could be seen for quite a distance and I counted 10 fire trucks that responded to the fire. The Highgrove station reported that there were a total of 31 firefighters and volunteer firefighters on the scene to put out the flames.

We returned the following day to take these pictures.



This photo shows some of the damage and how the roof fell into the covered swimming pool. If you look on the right side you can see the side wall of the pool. The roof was covered in corrugated tin and when the supports burned the roof collapsed. The firefighters did a great job but there was a lot of damage. It's hard to believe that the main house was saved from the intense flames.



We saw the wheels of the motorcycle on fire late Sat. evening and this is what was left the next day. Firemen are trying to determine what caused the fire.

### Grant applied for- to improve south side of Main Street

The new high school has prompted Riverside County to plan for improvements along the south side of Main St. between Sanrve and Michigan Ave. across the street from the new high school. According to Mr. Acuna they are hoping to build curb and gutter and a sidewalk on the south side. He also said that they are planning on having a traffic signal by the school entrance and that a small fence may be installed in the median on Main St. to discourage students from parking on the south side and having to cross Main St. to get to and from their cars. ## REDUCE REUSE RECYCLE

I hope you had a pleasant Earth Day 2009. I am hoping that someday Earth Day won't be a social event or a marketing opportunity. Keep Earth Day in your heart every day.

The economy is the buzz-word now. Many people are embracing the concept of reducing and/or reusing as a means of saving money and making each dollar stretch. A basic self-help activity is growing our own food. It is easy and do-able for anyone. Your "farm" can be as small or as large as you can manage: you choose your "crop" and varieties.

What kind of supplies do you need?

### Short List:

- Containers that drain well- repurposed items or build your own
- Potting medium (please no "dirt")
- Seeds

### Long List: add to the above

- Watering system
- Shade covers
- Tables, stands or shelves for containers

Growing herbs in pots in the kitchen window is easy for anyone to do. Basil, thyme, oregano, and parsley all do well. It is so wonderful to have fresh herbs literally at your fingertips when you are cooking! Herbs don't require much care, water or full sun and will grow by themselves. They love to be used; the more you trim them the better they grow.

Salad greens are very easy as well. Window boxes or any container that is 24x24 inches or larger and 6 inches deep can be used. For several years I have used on old square BBQ. The lid holds in warmth and moisture while the seeds sprout, there is built in drainage, and the wheels allow me to roll it to various areas of the backyard to work with the sun. I scrubbed it out well, removed all the racks and grates,

and filled it with a potting medium. I plant one-half at a time. After my first "crop" is up I plant the other half. This is called succession planting- ensuring that I can have a continuous supply of salad greens. Greens such as romaine, curly leaf, oak leaf, arugula, escarole, and spinach grow well together. The key to have tasty salads with no bitterness is to cut the greens when they are less than six inches tall, make sure they do not dry out and cut frequently. You can chop them off about one inch from the top of the soil. They will grow right back out. Radishes, green onions and smaller carrot varieties (Like Burpee "Short 'n Sweet") will grow very well in containers. They need a good amount of full sun so they won't do in a window- the patio or porch will fit best.

Table top gardening has become very popular, particularly for those who are not able to get down to ground level and want to have a larger crop of vegetables. The Maryland Cooperative Extension of the University of Maryland, has designed The Salad Table™ which is just the right size: 33" wide and 58" long. Constructed from 2x4s, it will produce one to two pounds of greens each full cutting! They have also designed a smaller version: The Salad Box which is 15" wide and 21" long and has handles on the ends. This is a great size for children and smaller spaces. With our mild winters and even with our hot summers, you can always have fresh salad greens at your fingertips. You can grow other shallow produce like scallions, radishes, and herbs like thyme and oregano as well.

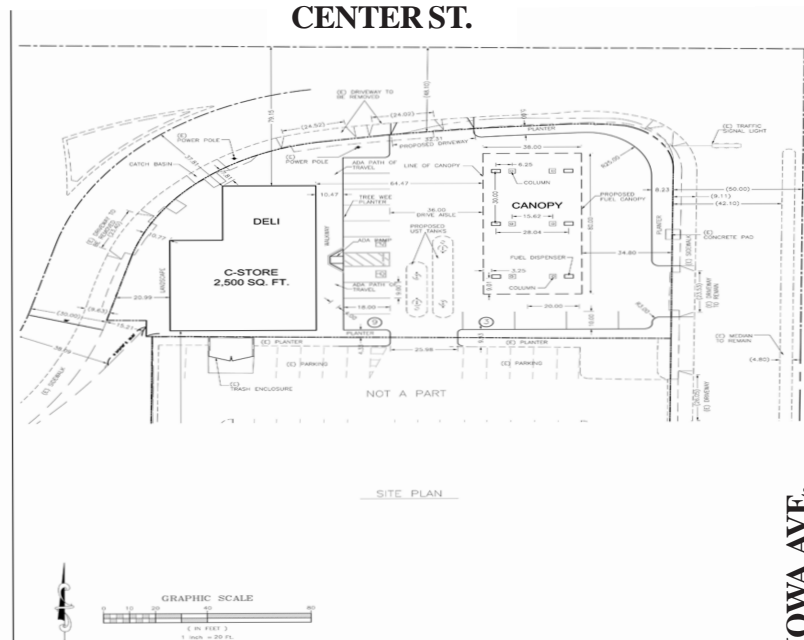

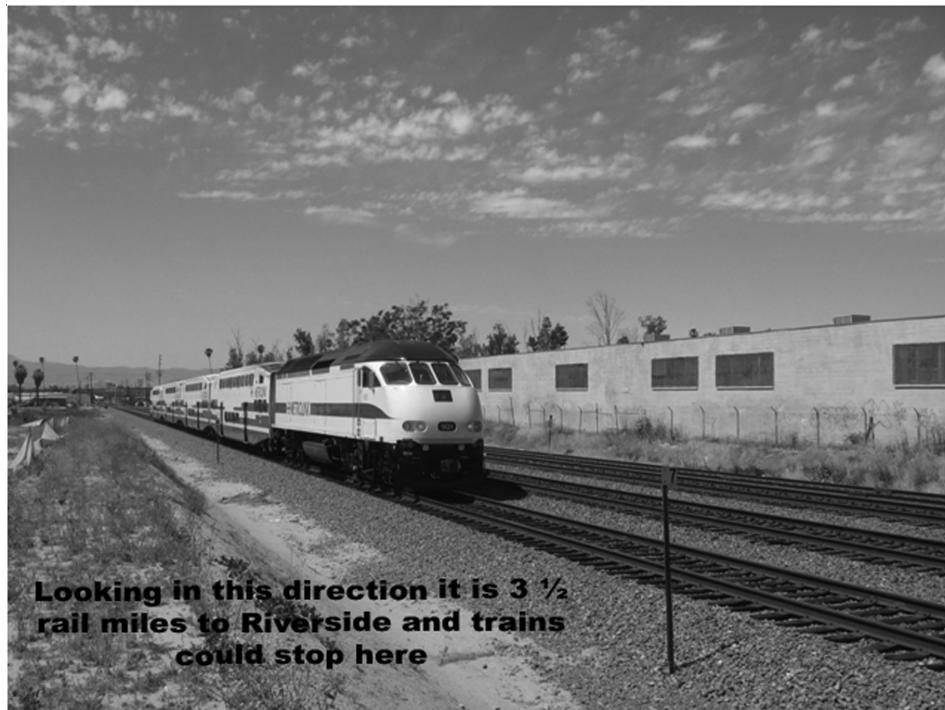

## Highgrove Metrolink plan facing rejection



I received a call from the Riverside County Transportation Commission and I was asked if I could attend a meeting in their office on April 27, 2009 in regard to the Metrolink stop in Highgrove. Ardie and I had been working on a power point presentation that was just about completed when I received the invitation. I thought it would be an opportunity to show our power point to those present so I called Friday before the Monday meeting to see if it would be possible to show our supporting documentation, photos, and reasons for locating the station in Highgrove.

I did not hear back from them so I took 5 copies of our power point to the meeting but I was not allowed to show those in attendance the power point we had prepared.

Ardie and I attended the meeting hoping that we could explain the photographs of the commuter trains passing through Highgrove, etc. but we soon

found out that the staff decision to reject the Highgrove site to the commissioners had already been made. This became a notification meeting of their decision that had been made instead of discussing the merits of various station sites.

Those attending the meeting were Ann Mayer, Executive Director of RCTC, Commissioner/ Supervisor Bob Buster, RCTC Commissioner James Potts from San Jacinto, Edda Rosso, Kathy Bechtol and John Standiford, Deputy Director of RCTC. Another gentleman was also there but I did not know him and we were not introduced.

Instead of a station stop at Highgrove, RCTC is considering purchasing the 25 acre property where grading for a 520,000 sq. ft. warehouse is almost completed between Palmyrita Ave and Columbia Avenue. (See P. 6 of Feb. issue) RCTC said that they would also need to purchase the 19

acre property we wanted for a station because it is needed for the curved track to connect the 2 railroads. RCTC wants to purchase 2 different properties 1/2 mile apart instead of just one piece of property at Highgrove. One would be for a station at Palmyrita and the other for the curve.

At the meeting, we were presented a detailed map that stated several reasons why the committee was against a station at Highgrove. Many of these same problems and solutions were addressed in our power point presentation that was not played at the meeting.

Some of the objections to the Highgrove site from the RCTC staff were:

(a) Villa St. would need a \$2 million dollar upgrade and would be the only access to the portion north of the proposed curve.

(b) A pedestrian crossing over the curved track would be too costly.

(c) Transit Ave. would have to be widened and homes possibly purchased.

(d) There is limited parking at the Highgrove site.

(e) Warehouse traffic would restrict access to the platform area.

There were other items listed but these were the main ones.

Here is my response to some of these objections:

(a) Villa St. could be closed and a new crossing made 1 block south at Spring St. which would be in a direct line from the future Spring Mountain Ranch homes.

(b) I suggested going under the track before the track is laid. It would be much cheaper to go under the future curved track and it could be made wide enough for a shuttle similar to the one used at the Corona Metrolink station instead of going over the track.

(c) Access to the north side parking lot could begin at Center St. at Transit and go behind the homes on


Transit Ave., west of the Perris Valley Line track to reach Villa Street which is only 1 block. Transit would not have to be widened or any homes purchased.

(d) Many years ago we tried to get RCTC to buy this location when there were 35 acres of vacant land available. Now there are only 19 acres left because warehouses have been built on the south side of the arroyo and they say the location is too small.

(e) There is truck access to the rear of the 2 new warehouses between the buildings on Citrus Street. The new roadway across the arroyo could be used for the primary access to the south parking lot for Metrolink commuters and the area between the buildings for the trucks.

Naturally we were disappointed that we were not able to show our power point presentation. The unfortunate reality is that the existing commuter trains will continue going through Highgrove 7 days a week on the BNSF main line without stopping during the Perris Valley Line construction period. This amounts to 3,224 commuter trains per year, just like they have done for the last several years.

After the construction on the PVL is completed, this new limited service will only transport commuters from Palmyrita Ave. to Riverside or Palmyrita Ave. to Perris. Unlike the station at Highgrove, the Palmyrita station on the PVL will not take commuters to San Bernardino because it goes in the opposite direction. The Palmyrita station is on the wrong railroad for commuters who want to go north toward San Bernardino. Under their plan, going to San Bernardino from the Perris area would require going to Riverside first, then waiting on another train connection and backtracking back through Highgrove to San Bernardino. The possibility of having 2 train schedules that

would connect the PVL trains with the Riverside commuter trains that go to San Bernardino is very unlikely!

For several years we have been trying to get commuter rail service that will benefit the surrounding area and the region. We have tried to get Riverside and San Bernardino transportation agencies (RCTC and SANBAG) to cooperate for the benefit of the commuters that live on both sides of the county line. We have written support from surrounding cities that date back to Dec. 13, 2001. RCTC is the lead agency because it is in Riverside County but it seems that RCTC is only interested in train service between Riverside and Perris and has ignored the existing commuter trains that already go between Riverside and San Bernardino. Some of this may be expected to a certain degree, but our transportation tax dollars should be spent on transportation services that will benefit the entire area-not just one destination. We know that Highgrove is close to the county line but there is no division or interruption when our automobiles cross the Riverside/San Bernardino County Line on the I-215 freeway at Main Street. The I-215 freeway benefits residents on both sides of the county line but this plan for new commuter rail service proposed by RCTC does not!

The Highgrove location came from the people and has been supported in every direction for over 7 1/2 years. The issues raised at the meeting on April 27,

2009 by RCTC, are not physically impossible and if RCTC wanted this to work, I am sure they could have found a way to make it happen! If these decisions are being made by anyone who will benefit from the increased accessibility of freight trains to the Perris Valley area under the guise of commuter train service, instead of addressing the commuter rail needs of the people in both counties, then we have a problem! (This statement is not an accusation directed at any group or any particular person).

We have asked for one platform to be located where there are existing commuter trains at Highgrove that could also be used by future commuter trains on the Perris Valley Line.

One platform at Highgrove could serve as a pivot point both ways, for commuters in all three directions: To and from Riverside, To and from Perris, and To and from San Bernardino!

We have had community support for 7 1/2 years but now we need the RCTC commissioners to look at the power point presentation before the station locations are finalized. \$45 million dollars of our Federal tax money has been allocated for the Perris Valley Line in this \$163 million dollar project. We do not oppose the new commuter rail service on the PVL but we do object to locating the station at Palmyrita, Marlborough or anywhere in-between Highgrove and UCR. The station needs to be in Highgrove on the west side of the new curve! (see above right)

## Columbia Ave. to be closed during overpass construction!

## VIRGINIA'S VIEWPOINT

### SCHOOL BOARD STUBBORNLY REFUSES TO CHANGE ITS POSITION

I attended the Colton Unified School District's meeting held late last month. There were about 300 people in attendance, so many that the crowd spilled out into the parking lot. Fire officials refused to let some into the room which was already filled to capacity with many required to stand.

I have been trying to determine who the person or committee is that governs the school board. I admit to a great deal of ignorance about the political system. I realized several years ago that we are not in the least governed by people who give a tinker's damn about what we want or need. The position of the school board to ramrod the idea of naming Grand Terrace High School after Ray Abril Jr., a retired school board member is an abomination. Most of us do not even know him. I understand that those who are acquainted with him believe that he is a good man and did a good job when he was a member of the board. Why is that a reason to name a school after him that has absolutely nothing to do with him? The students of Grand Terrace High School will not even know who he is nor why the school board was so adamant about naming it after him. Can't you just hear them:

"Who was Ray Abril Jr.?"

After a previous meeting of the board I gave them a typewritten speech I had intended to give and was refused admission to the podium, that gave the board an out for their embarrassing position of being told that most of the residents of Grand Terrace wanted their high school named after their city. They ignored my letter. My

attempt to help them save face was simply that they rename Colton High—Ray Abril Jr. Colton High. I heard not one word from any member. I have an idea they filed my letter (speech) in the round file.

I am in the minority of those who do not believe we need a high school. I have been against it since the idea was formed about 25 years ago. I do not believe we need the expense and according to Steve Berry, our acting city manager, it will not cost us anything. There is such a thing as convincing yourself that something is true that you lose all sense of reality. This school is going to be costly and it will involve problems in which the Ray Abril Jr. issue is merely the beginning.

There will be disciplinary, social, physical and regulatory problems. There will be problems having to do with maintenance of the school such as trash removal, fire protection, toilets, nursing help, water supplies, security—the list is endless. Guess who will be paying for these services? Who is going to provide security? Do you really believe that this high school will be a peaceful, warm, socially upbeat, academically successful institution without the problems all high schools face such as drugs, guns, fights, destruction of the very place where they go to get education to prepare them for college? If you do you are sticking your head in the sand as Steve Berry is.

Another vote was taken and apparently, the board is stubbornly refusing to change its decision. Many in the audience were thoroughly dissatisfied with the result of this meeting and one

man in the back was loud and unruly. He was rude. That is not the way you get through to a group such as the school board.

### FOURTH OF JULY FIREWORKS

It is my understanding the City of Grand Terrace Council persons have given the sports groups permission to erect and sell fireworks one more time in Grand Terrace. I sincerely hope that

none of their children or grand children ever become injured by the usage of fireworks. It was my belief that setting them off in Grand Terrace was illegal. Does it make any sense how it is okay to sell them here? **Finis**

limit rule and many people in the crowded room were angry that their voices were not heard. The chair called for other speakers who were in favor of another name besides Grand Terrace High School under public comments. There were a couple of speakers who supported the Ray Abril Jr. name and a vote was taken to name the school after Ray Abril Jr.

Board member Pat Haro was the only member who did not vote for the Ray Abril Jr. name. Many Grand Terrace residents were infuriated and felt this action was pre-determined.

Then at the following school board meeting on April 23, 2009 at the same location, the subject of the name was on the agenda again and the room was filled to capacity with an overflow of people carrying signs outside the entrance into the parking lot and along Mt. Vernon Avenue. Some of the people were asked to leave by the fire marshal but were allowed to go back

inside to sign the register then go back outside. The room capacity is 134 people.

Grand Terrace residents have collected 3,600 signatures to change the name to Grand Terrace High School and people are very passionate about this name.

Also, at the April 23, 2009 meeting, board member Robert Armenta spoke from his seat during the "public comments" period in favor of Ray Abril Jr. High School.

**In my opinion I feel that the Ralph M. Brown Act may have been violated, not because there was a 3 minute time limit or a 15 minute maximum on this subject but because the decision was pre-determined and the public comments period was taken up by reading a letter or listening to a board member instead of hearing from the public under "public comments".**

## A "LOVING" LOOK AT POLITICS

Education Costs are too high in California

To be honest, education costs are too high everywhere but because education unions have such a strong foothold in California, the taxpayers and parents are an easy prey for these unions. As a former education administrator and currently an international graduate level professor, hopefully, this column will expose the discrepancies in your child's school and will give you the initiative to do something about it.

For example, unions have demanded that the number of students in a classroom be limited to a certain amount. Why? Because a school district will have to hire more teachers, build more classrooms, and provide administrative services to parents, teachers, and students. And you, as the taxpayer, foot the bill. I think ever parent should go into their children's schools and meet with the administrators and ask them how many good, well qualified teachers have left their district because of the incompetence of the other teachers and the harassment of the local union. Unions will protect the incompetent teachers to the point where the school district real-

izes the cost of paying the legal fees to get rid of the teacher will cost more than the salary of the teacher and the unions know this. Therefore, if you are a sixth grade teacher and the fifth grade teacher is incompetent, you not only have to teach your students required by the sixth grade standards but also teach remedial courses to catch the students that were passed because the fifth grade teacher didn't do their job.

In all of my years of being in education, I have never understood why there has to be a ratio of teachers to students. A good teacher, I mean a well qualified, dedicated teacher doesn't care how many students are in the classroom as long as the teacher has the authority to discipline the unruly students and the administrators back the teachers' decisions. Of course, this is the biggest joke of all. Administrators, first of all, are extremely overpaid but are scared to death of a lawsuit. Parents of minority students know this and use it very well and in the past have won huge lawsuits because of liberal Judges and an education system that has forgotten that ALL the students in that classroom are entitled to an education. Yet, one student can disrupt the entire process and if the teacher decides to discipline, say a minority student, the parents immediately scream "Racial prejudice" and the unions jump on that issue, sue and usually win suit thereby reinforcing that unruly students have more rights than good students.

In closing, I know this is a complex issue and there can be arguments on any one of a hundred points which can last for years (and has) but the bottom line is that education is really BIG BUSINESS and the unions know this. Just check the government budget on edu-

cation and the total budget and you will find that education is the number one business in America. There are solutions but there is no room in this column to recommend them. Maybe the next column.



**Proper Disposal of Medication and Sharps**

Most medications are not considered hazardous waste and can be disposed of in regular trash. Remove personal information from containers before disposal.

**Liquid**.....Empty liquid medication onto absorbent paper towels or rags and throw IN TRASH.  
**Pill**.....Crush pills, mix with coffee grounds or kitty litter, and dispose of mixture IN TRASH.  
**Inhaler**.....Empty container, expel propellant, and toss empty cylinder IN TRASH.  
**Sharps/Needles**.....Must be placed in a secure approved sharps container and brought to a Household Hazardous Waste collection for disposal. FREE Approved containers are available while supply lasts. If a container is not available, put sharps in rigid plastic jug (bleach bottle), tighten lid, secure with tape, and place label "SHARPS/NEEDLES".  
**ALWAYS BRING SHARPS TO HHW PERMANENT FACILITY OR TEMPORARY EVENT.**  
 Check with your local City Hall for additional Sharps disposal collection programs.

**Universal Waste**

The following items can't be tossed in the trash. They contain harmful chemicals and need to be disposed of properly through the Household Hazardous Waste Program (see front schedule).

- Common Batteries: AA, AAA, C & D cell and button batteries (e.g. hearing aid & watch batteries). Automotive type batteries are not Universal Waste and are regulated under a different law.
- Fluorescent Tubes, Bulbs and other Mercury-containing Lamps: fluorescent light tubes and bulbs, High Intensity Discharge (HID), metal halide, sodium and neon bulbs.
- Electronic Devices - TV's, computer monitors, computers, printers, VCR's, cell phones, telephones, radios, and microwave ovens.
- Non-empty Aerosol Cans that contain hazardous materials (labeled toxic, flammable, or corrosive).

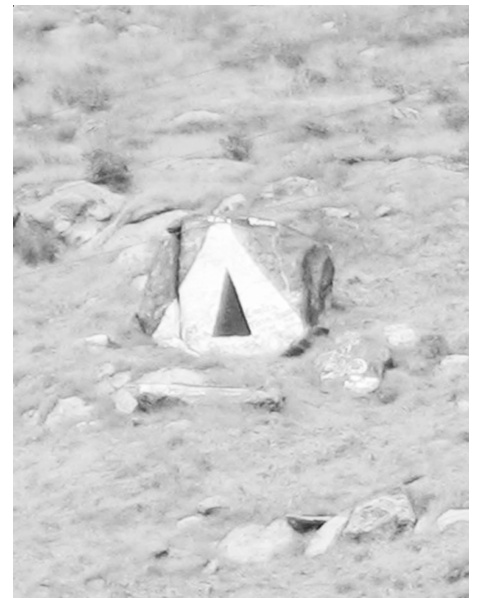
## TEE PEE ON BLUE MOUNTAIN

The TeePee was painted on a Blue Mountain Boulder for The TeePee Ranch, a horse ranch at the end of Main Street in Grand Terrace once owned by silent movie star, Clara Bow and her husband B Western star, Rex Bell. Clara was known as the "It" girl because she had "It". She was the star of the first movie to win the Academy Award - "Wings". Rex Bell was later elected Lieutenant Governor of the State of Nevada.

In the 1960s and 1970s, the TeePee Ranch was owned by Roy Anderson, owner of Anderson Van and Storage in Redlands. He called the ranch Anderson's Arabians.

If you haven't noticed the Tee Pee before, the next time you drive down Mt. Vernon, look at Blue Mountain and you will see the Tee Pee painted on the rock. I have lived in this area for many years and it was here when we came to California in 1946. The property is currently owned by Don and Marlene Ritz, who have owned Fair Price Carpet in Highgrove for over 40 years.
