## Grand Jury closes investigation on parcel fees for Highgrove Sheriff!

We have still been receiving signed petitions for a Grand Jury Investigation from residents on the east side of I-215 because we are still paying for the dedicated Highgrove Sheriff Deputy that was eliminated about 6 years ago. A request for a Grand Jury Investigation was filed on June 24, 2016 on behalf of the Highgrove residents who paid for their own Sheriff Deputy that was assigned exclusively to the east side of the I-215 freeway that was a special assessment that was paid with their property taxes. The complaint included 47 pages of documents

including photographs and copies of the 1992 ballot and the 1997 ballot that were mailed to the Grand Jury. The Highgrove Happenings included a form that residents could fill out asking for a Grand Jury Investigation that were mailed in for forwarding to the Grand Jury. Members of our community circulated petitions door to door that were also mailed to the Grand Jury. But on August 29, 2016 I received the following letter from the Grand Jury which offered this brief explanation:

## Request for extra Sheriff protection was done the right way!

In a Preass Enterprise article on March 14, 1991 a Highgrove resident was quoted saying: "In the past 6 months I have been broken into twice and I have waited for 4 hours for the Sheriff's Department to come" and in another Press Enterprise article the pastor of the United Methodist Church, Virginia Fifield at that time, said the parsonage where she lives, has been burglarized five times and the church sanctuary was burglarized twice. These and other comments resulted in the community responding by asking Riverside County for a Deputy Sheriff assigned exclusively to Highgrove on the east side of the freeway. The cost had previously been set at \$10.00 per month per parcel.

At Highgrove's CSA 126 Community meeting on Feb. 12, 1992 the minutes show that the \$10.00 per month assessment would be broken down to \$7.96 for extra police and

\$2.04 for park and recreation.

In 1992 a ballot was distributed to property owners on the east side of the freeway only because the west side did not want to pay for the extra Sheriff. The first line of the 1992 ballot stated: **"The need for extended police protection will be decided with this ballot."**

There was a YES box and a NO box to indicate if the property owner wanted to: **"Continue present level of police protection with no increase of parcel fee"**.

The ballot passed and the county was notified in a letter dated Feb. 25, 1992. Then in 1997 proposition 218 required that assessments or fees had to be re-affirmed by a 2/3 vote and another ballot was voted on that passed by 75.8 % of the Highgrove property owners. The proposition was known as Measure T. There were no arguments printed against Measure T and yours truly (R. A. Barnett)

Barnett) wrote the Argument in favor of Measure T.

Also the most important part of Measure T was the impartial analysis of Measure T written by William C. Katzenstein, County Council, County of Riverside. Here is the most important part of the impartial analysis:

**"THIS TAX WILL BE RETAINED IN THE CSA 126 FUND TO BE USED ONLY FOR PURPOSES OF CONTINUING EXTENDED SHERIFF, AND PARK & RECREATION SERVICES AND IMPROVEMENTS."**

The last vote on this issue was taken in 1997 and according to the County's interpretation, and since the taxes are still being collected for the special assessment there should be a "CSA 126 FUND" to be used only for the extended Sheriff or Park & recreation services and improvements.

The Riverside County Economic Development Agency shows that the extended Highgrove Sheriff Deputy's position was eliminated on Dec. 30 2009.

Here are the figures from the Riverside County Auditor's office that show how much was collected after the Sheriff was eliminated:

Note: 1/2 of the 2009/10 costs were during the extended Sheriff's on duty time from July 1, 2009 to Dec. 2009. And the 2015/16 figure shows a marked increase that was collected. If Spring Mountain Ranch properties are paying the fee then we would      Cont. on P. 3

## Fatal Traffic Collision

RIVERSIDE COUNTY, California- On Wednesday, August 31, 2016, at approximately 2:06 pm, an adult female driver was driving a 2003 Toyota Corolla, southbound on Interstate 15 north of Mission Blvd. For an unknown reason the driver was driving at a high rate of speed within the dirt center median, approaching a steep dirt embankment at the Mission Blvd. under-crossing. The driver continued within the center median until the vehicle traveled down the embankment, colliding with a tree as well as the embankment. Emergency personnel responded and transported the driver to Kaiser Hospital in Ontario, where she succumbed to her injuries. The identity of the decedent is unknown at this time; pending identification by the San Bernardino County Coroner's Office.

like to see what amount is going into the **“FUND” TO BE USED ONLY FOR PURPOSES OF CONTINUING EXTENDED SHERIFF, AND PARK & RECREATION SERVICES AND IMPROVEMENTS.**

Another question that needs to be answered is: Has there currently or has there ever been a “FUND” established that address these specific purposes? This should have been a simple bookkeeping item that would show how much was in the “fund” each year.

And if any of the special assessment tax money was given to the Sheriff Dept. for any other purposes other than the east side of Highgrove, then a miss-appropriation of funds may need to be implemented because this assessment was for specific services only in Highgrove.

Another question that needs an answer is: Why was the designation or name of the assessment changed on our tax bill without a vote? The previous years all indicate the special assessment to be CSA 126E but now appears on our tax bills as CSA 126, PARK & REC LNDSCPE.

On August 5, 2015 when I gave Supervisor Tavaglione the request for an audit, I told him this issue would not just go away.

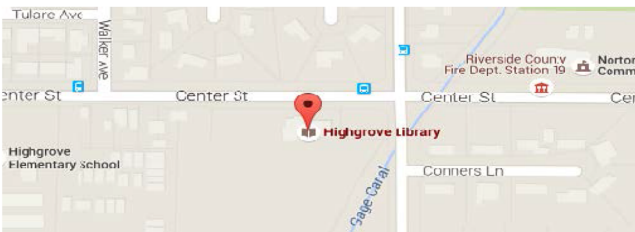

The nails had to be removed in order to pull the beveled siding straight down so the old siding could be removed. New redwood siding was no longer available but thanks to Champion Lumber, a company was found in Los Angeles that took a special order and duplicated the siding with new redwood just like the original. Each piece is 2 boards wide and the lower lip of the board fits over the previous panel. When we picked up the new siding they were in 20 foot lengths that had to be cut in order to get them into the truck.

### Riverside Line Pedley station to change name to Jurupa Valley/Pedley station

Effective October 3, Metrolink's Pedley station on the Riverside Line will be renamed to the Jurupa Valley/Pedley station.

The station's name is being updated to reflect the city's incorporation as Jurupa Valley.

When the Pedley station was created in 1993, it was located in an unincorporated area of Riverside County. In 2011, this 44-square mile region was incorporated as the City of Jurupa Valley, which encompasses the Metrolink Pedley station.

Due to the renaming of the station, ticket vending machines will require passengers to select "J" for Jurupa Valley/Pedley instead of "P" for fare media to and from the station formerly known as Pedley.

Pedley station information seen in the Metrolink timetable, station signage, online, and other sources will be listed as Jurupa Valley/Pedley information as of October 3.

The un-used vacant on the inside and outside of this curved track is where public support has been received for 15 years for a parking lot. A parking lot here would be for commuters using the straight track, in the distant behind this train, using the existing Metrolink trains on the BNSF Main line between Villa St. and Iowa Ave. that operate between Riverside and San Bernardino counties. The train shown above does not stop at this location. It's last stop was Riverside station and it's next stop is the new Marlborough Ave. station. 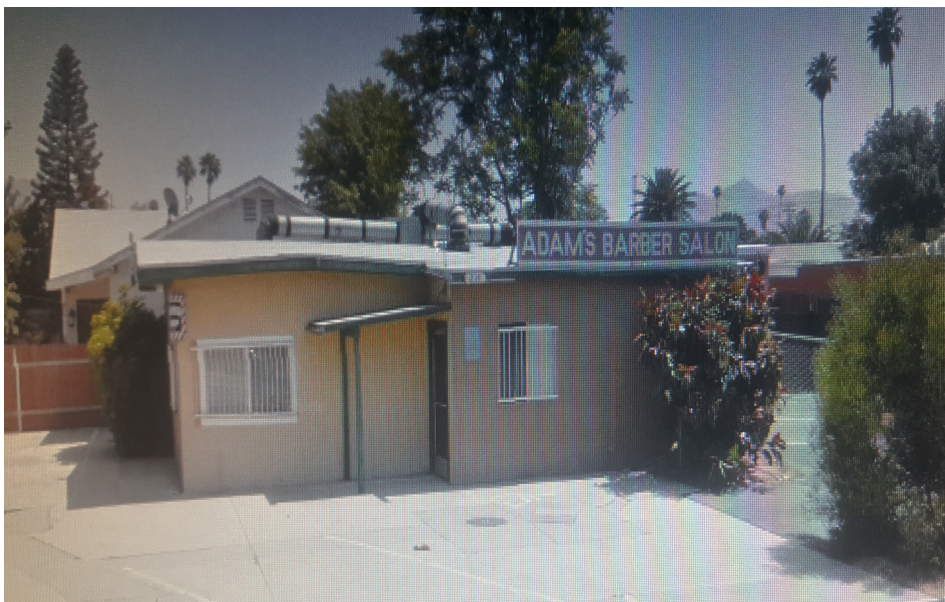

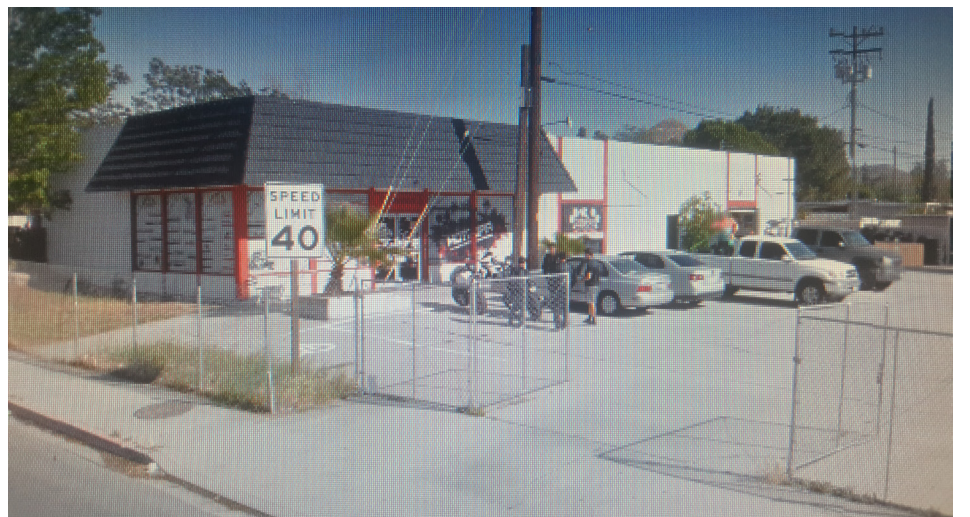

After the hide-splitting public opinion lashing Martin Shkreli received because of the outrageous price hikes of his company's drug Daraprim (an anti-parasitic medication used by pregnant women and others with compromised immune systems), one would think an intelligent CEO of any company would think very carefully before introducing a huge price hike on a very popular life saving medication. How insulated are they, how disconnected from the real world are they, that they think it would go unnoticed and be acceptable?

Epinephrine is a lifesaver- it saved me once when I had an allergic reaction during a medical procedure. The EpiPen has been used to save countless lives, including my cousin's. Up until recently it was somewhat reasonably priced and available to everyone. In 2009 a two-pack of the Mylan product cost \$99. Considering the pen may never be used and have to be disposed of, \$99 hurts but it's doable. Also, students need several available; usually one on them in a backpack, one with the school nurse, one in the classroom, one with a parent, and one at home in a drawer or cabinet. And they need to be replaced almost yearly. When Mylan hiked the price to \$600 for a two-pack this last May, the concept of reasonable, available and doable was gone. People were angry and they were scared. Readily available epinephrine is literally a life saver. It is not optional medication. Mylan threw the public a bone and provided discount coupons but the price is still out of reach for most people.

The most significant drawback to epinephrine in any form is that it has a short shelf life. Currently the FDA acceptable life span for an autoinject epinephrine pen is 18 months and that's if it is stored in ideal conditions. Many people keep the pen in the glove box of their car; because of the heat, it can greatly reduce the effectiveness of the epinephrine. A study published in May 2000 reported that an EpiPen that is out of date- they tested ones that were one to ninety months out of date- were at best 65% effective. They concluded that the out of date ones could be used as long as there

was no discoloration or precipitates in the solution- the risk outweighed the benefits. The problem is that one may not take a close look at the solution when a person is in the throws of anaphylaxis and could die. With the outlandish price hike, many patients are looking for solutions. A web search revealed very few safe solutions, some coupons and some supplies for DIY pens; there are YouTube videos on how to DIY a pen (NOT recommended!). As with all pharmaceutical purchases made from an on-line source, it is highly risky to purchase from an unknown vendor. There is a very long history of medicines being sold on the internet that are of poor quality, completely inert, or at times, made with ingredients that are a health risk.

Typically a medication that's been on the market for a number of years will have a generic version available. In this situation, it's not the medication that's protected, it's the delivery system- the auto injection pen which is a device and doesn't fall in the same category as medication. So the options are severely limited. The August 2016 Consumer Reports magazine relayed this information: "the authorized generic of Adrenaclick (epinephrine auto-injector), is a cheaper option—we found it for \$142 at Walmart and Sam's Club using a coupon from GoodRx. While generic Adrenaclick isn't the same technology and is used differently than EpiPen, both auto-injectors contain the same drug, epinephrine, available in the same dosages, says Barbara Young, Pharm.D., of the American Society of Health-System Pharmacists." Epinephrine is an inexpensive, readily available medication so there's not been any motivation to patent another delivery system other than EpiPen. The world's been happy to let Mylan carry the ball. Consumer Reports also mentioned that the crucial ingredient, epinephrine, is available in a bottle but has a very short shelf life, about 90 days. It is considerably less expensive but one must be trained on how to draw the medication in the safe correct dosage and then inject it properly- all while under stress when a loved one is having an anaphylactic attack. Clearly not an ideal time to be playing doctor. So what is a person to do? First, be very attentive to the availability of coupons for either the EpiPen or

the Adrenaclick. This is a financial solution. However, this doesn't address the biggest problem, the one of "Big Pharma" greed and predatory pricing. As with all things concerning money, the consumer must become an advocate and warrior to protect themselves. Become an activist. Even if the EpiPen is not a personal issue, there WILL be another medication someday that will eventually get too expensive for you. I think most of us can agree that there is something very wrong when a drug company CEO

pulls in a paycheck of over 18 million dollars a year. YOU are paying that! If you have insurance that is paying, you are still paying that via your premiums. Write letters, make phone calls to your elected officials and insist that the system be changed. Don't just gripe though; make a few reasonable solutions for them to work on. And get others to work with you. Hopefully a child won't have to die from the lack of an epinephrine injection before we see changes.

## County of Riverside Code Enforcement Department

### Church Becomes Marijuana Dispensary

Code Enforcement received a complaint of a Medical Marijuana Dispensary (MMD) operating at a property in the community of Home Gardens. Upon arrival, staff found that the MMD was operating at a location that was once a church and near the Home Gardens Academy, a school that serves grades K-8. The school was less than 600 feet away from the dispensary.

Contact was made with a security guard who verified that a marijuana dispensary was operating at the site. As with most dispensaries, the lobby was set up with security cameras, sign in sheets, and marijuana paraphernalia. The other rooms of the building were secured with no immediate access; however, there was strong odor of marijuana permeating throughout. Permission to inspect was asked for but denied by the security guard. A consensual inspection was conducted later with both the property owner and the marijuana



dispensary operator. Staff explained the County's outright ban against dispensaries and the direct conflict with the Health & Safety Code, but it must not have sunken in because the business continued to operate illegally after the Notices of Violation were issued. Code Enforcement personnel put together a Task Force comprised of County of Riverside Sheriff Deputies, State of CA Employment Development Department - Underground Economy Section, State of CA Department of Industrial Relations - Division of Labor Standards Enforcement Bureau, and County District Attorney Investigations Bureau and re-inspected the site. The MMD was closed soon after.

### RTA GETS GLOWING FEEDBACK FROM MAJOR AUDIT *Ridership increased, service expanded during healthy three-year period*

**RIVERSIDE, CA — September 23, 2016 —** Propelled by a recovering economy, the Riverside Transit Agency (RTA) expanded service, boosted ridership and planned for future growth, according to a new audit that inspected virtually every area of operation over a three-year period.

The Transportation Development Act (TDA) Triennial Performance Audit, commissioned by the Riverside County Transportation Commission (RCTC), found the Agency in compliance with all areas of inspection, including administration; scheduling and dispatch; maintenance; marketing and public information; service planning; and general management and organization. The audit covered fiscal years 2013 through 2015.

During the three-year audit period, RTA's ridership grew by nearly 10 percent, from 8.4 million to 9.2 million boardings. The audit also determined that RTA's farebox recovery ratio (or the percentage of operating costs covered by passenger fares) hovered between 26 and 29 percent during the three-year period, easily exceeding the state's required minimum farebox ratio.

During the audit period, RTA modernized bus stops at the Galleria at Tyler in Riverside, concluded a major study that identified service upgrades for the next decade, continued work on the RapidLink express service project in Corona and Riverside, and improved routes to serve new and expanded Metrolink service in Riverside County. The Agency also received a regional clean air award for its use of compressed natural gas vehicles and its partnerships with area colleges.

RTA Chairman of the Board Frank Johnston said the audit reflects RTA's commitment to using taxpayer dollars wisely.

"Passing this audit with flying colors reflects RTA's conservative business approach and our commitment to operate a world-class transit system --- from the top management to the bus drivers and mechanics --- that adapts and thrives over the long run," Johnston said.

The audit is required every three years for agencies such as RTA that apply for and receive state funding. Specifically, those state funds are tied to TDA revenues: Local Transportation Fund (LTF) and State Transit Assistance (STA). Over the course of several months, auditors interviewed RTA management, collected and reviewed documents and inspected the Agency's facilities. No deficiencies were found in any of the reviewed areas.

RTA's service area spans 2,500 square miles, among the largest in the nation. 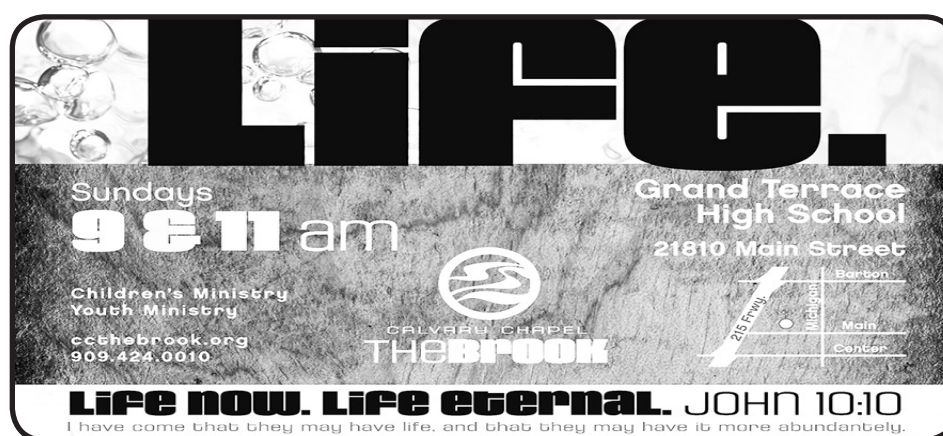
