Changes "Happening" In And Around Highgrove









RCTC responds to letter

My article in the Sept. issue about RCTC failing to respond to my July 27th letter has received a response from Ann Mayer, Executive Director of RCTC. The letter was addressed to her because she is the Executive director of RCTC.

As per her request, here is her entire un-edited letter:



Riverside County Transportation Commission

September 1, 2010

Dear Mr. Barnett: "Thank you for your letter of July 27 regarding the possibility of a train station in Highgrove.

I think the position of the Riverside County Transportation Commission (RCTC) regarding this matter has been rather consistent and transparent. You have had a number of opportunities to meet with our Commissioners and staff and had the opportunity to make detailed presentations to various Committees and the entire Commission.

You have asked for me to list the Commission's reasons for choosing a location serving Hunter Park instead of Highgrove. Rather than merely list arguments, I would like to provide a detailed explanation for our actions. I would hope that you would print this letter in its entirety on your website. I respect your dedication and efforts on behalf of your community, but this is an issue where we will continue to have significant differences of opinion. Our position is based on sound engineering, operational complications, and costs including:

Conflicts with Railroad Mainline There are a number of operational engineering, and ridership

challenges with a station location in Highgrove. Unlike the Hunter Park area, Highgrove is not an employment center nor does it have the population density to support a train station when the Downtown Riverside station is only two miles away. To further complicate matters, its location on the mainline of the Burlington Northern Santa Fe creates a number of operational concerns that impact dispatching and the need for complicated switching facilities. These concerns were addressed - at considerable cost at the Downtown Riverside station; to do the same at Highgrove would be exceptionally expensive and a questionable investment given its proximity to a similar location only two miles away.

Direction of Train Service

One argument that you've often made in locating station at Highgrove is that there already a number of trains that travel through Highgrove, why not just place a stop along the corridor and stop the trains now? Let's assume that the operational concerns mentioned in the previous paragraph were 'not an issue; are there enough trains and passenger demand for a station in Highgrove?

The answer will surprise you. Train schedules are set in a way to meet demand and trains do not travel back and forth between Riverside and San Bernardino. Consider that the Downtown Riverside Station served by 35 daily trains. The stations at La Sierra and Corona are served by 20 trains per day and even the least-used RCTC train station in Pedley is served by 12 trains. Building a station in Highgrove today to be served by only 8 trains is not a cost-effective investment.

Highgrove Engineering Challenges

On January 25, 2010, you had an exclusive audience before our Perris Valley line Ad Hoc Committee and you were accompanied by a civil engineer - Mr. Addington. Previously, you had met with members of our Commission who went to the Highgrove location for a first-hand look at the site. The purpose of both meetings was to explain numerous engineering challenges that make it much harder and much more expensive to build a station at Highgrove. There are 13 different issues regarding the Highgrove location that create significant engineering challenges. They include the need for a grade separation at Villa Avenue and an underground pedestrian crossing under the tracks. Drainage is yet another problem. In the February edition of Highgrove Happenings, you pointed out that Mr. Addington believes that the engineering challenges can be overcome. What you failed to mention was the extra cost that would ensue - costs that could double the overall outlay for building a station at Highgrove instead of at Marlborough.

Highgrove Residents Will Be Served

As you've mentioned, you have worked on this issue for a number of years. Your dedication to the area is admirable and you reside in an important and exceptional community. Highgrove deserves the very best from the county of Riverside in terms of services and facilities, but train stations need to be located near residential or employment density. The Marlborough location

is sited near a jobs-rich area and will be used primarily by people who will be getting off the train in the morning and returning home in the evening. The best news is that it's easily accessible for Highgrove residents.

I think you should also consider the local impact a train station near a residential area can have on its neighbors. In order to access a station at the site you have identified, Transit Avenue would have to be widened to accommodate cars wishing to access the station, which would increase traffic near the neighborhood. Also, think of the many buses that would have to reach the station via Citrus Street. In addition, residents immediately east of the station would see a major parking lot built next to their homes. Contrast that with our preferred location on Marlborough Avenue in a primarily industrial area that is already designed with access for larger vehicles.

The Bigger Picture and the Future As many of our Commissioners have often noted, your commitment to your community is admirable, however in recent months some of your strategies to influence decision makers might have been counterproductive. Personal attacks are counterproductive and it's important to stay focused on the issue. For example, I can assure you that SCAG is great planning agency but has absolutely no jurisdiction over transit operations and funding. The city of Grand Terrace is unable to financially participate in the construction of or ongoing maintenance of a train station - especially if it's located in another county. Moreover I've noticed that you are trying to make the point that a warehouse is being developed on Palmyrita although

our environmental document makes it perfectly clear that there are three sites under consideration including Marlborough Avenue.

RCTC is committed to working with you on issues of concern and we will always welcome your participation in our meetings and events. In the case of Metrolink train stations, our aim will be to develop stations near residential or jobssense areas and are cost-effective to build and maintain. I'm afraid that's not the case with the Highgrove location. Thank you again for you ongoing interest and I look forward to your continued participation.

Editor's comments about Ann Mayer's Letter:

First of all, if criticism of RCTC policies were taken as a personal assault on anyone especially Ann Mayer, I apologize! I have a great deal of admiration for her and we have agreed to disagree because we are at opposite ends of this issue.

Here is my response to her letter:

"the need for complicated switching facilities" is not required just to stop some of the existing commuter trains through Highgrove because the commuter trains already run in both directions on the # 3 mail line right next to the vacant field.

We have not said that the existing

trains go "back and forth" between Riverside and San Bernardino" but we have stated they operate between these 2 cities through Highgrove.

The 8 trains you mention do not include your proposed future trains between Riverside and Perris that will also go through Highgrove.

Several items in the RCTC letter need to be corrected such as the distance between Highgrove and Riverside is 3 ¹/₂ miles, not 2 miles.


The 13 reasons given for not being able to build a station in Highgrove were prepared by your consultant and we have challenged them as manufactured to support your position.

All 3 of your station sites are over one mile from connecting to the existing Metrolink commuter rail network. And the Marlborough location is the furthest away!



The 1.5 on this railroad sign at Marlborough Ave indicates it is $1\frac{1}{2}$ rail miles to Highgrove where there



are existing Metrolink trains. There are no existing Metrolink trains on the Perris Valley Line track!

DESTINATIONS ARE THE **MOST IMPORTANT FACTOR!** THE RCTC PLAN WILL NOT **STOP THE CURRENT DAILY** COMMUTER TRAINS BE-TWEEN SAN BERNARDINO AND RIVERSIDE, even if they are allowed to build a station at Palmyrita Ave., Columbia Ave., or Marlborough Avenue. Under their plan the existing Metrolink commuter trains will continue to go through Highgrove without stopping just like they have done for the last 9 years.


Almost 4 years ago, former San Supervisor Dennis Bernardino Hansberger was quoted in the San Bernardino SUN on Dec. 31, 2006. The San Bernardino "SUN" stated: San Bernardino County Supervisor

Dennis Hansberger believes there is enough demand for a Metrolink station in the Highgrove area. "It's a very worthwhile objective" Hansberger said.

"Unfortunately, the people in Riverside County who have jurisdiction have not shown a lot of interest. But we are willing to try to get that discussion going."

Yes, for 9 years we have been trying to get RCTC and SANBAG to cooperate for the benefit of the region but it is apparent that RCTC only wants to serve Riverside County.

A station platform for the existing commuter trains at Highgrove could have been used for the last several years and the same exact platform could be used for future commuters between Riverside and Perris when the Perris Valley Line is completed. The 19 acre Highcontinued on page 9

Liz is now a regular at the Women's Free Homeless Clinic and the clinic at Pershing Park every Wednesday. During our last encounter Liz was filled with good news; her laptop had been returned! She pointed to her bag and then pulled it close to her chest. Her prized possession in her embrace and her glowing grin was a picture worth remembering.

But this wasn't the only news that Liz had to share with me. She set her laptop on the floor, moved her hands towards her belly and exclaimed, "And.... I am pregnant!!" I stood there, shocked, and unable to speak a word. A cloud of questions raced into my mind. How was she planning on raising a baby without proper shelter? Raising a baby is tough I would no longer be seeing Liz enough without having to worry where your family is going to set up camp for the night! 

grove property is a "must have" in order to operate new commuter trains between Riverside and Perris because it is needed for the curved track to connect the Perris Valley Line Railroad to the BNSF Railroad and is the only property that is needed! There is no need to purchase any additional property at Palmyrita Ave., Columbia Ave., or Marlborough Ave. because the station platform could be located on the west side of the 19 acres. Taxpaying citizens are becoming more and more aware and informed than ever before! Present communications systems such as the internet, texting, cell phones, etc., make something that used to be taken for granted or unnoticed that is suddenly captured on a cell phone camera and broadcast to the world over the internet.

Communication is very important but so is transportation. Station location is the most important factor in the Metrolink system because of the destinations. For example, for 9 years RCTC's choice for a station has been a political decision that has ignored the present and future transportation needs of the region. Their policy continues to ignore the facts that Highgrove (which is in Riverside County), has vacant land with hundreds of parcels ready for homes and is located at a natural railroad junction point where there are existing Metrolink trains that pass right next to vacant land that is the same land needed to connect the 2 railroads. A platform on the west side of this property will serve 3 cities, Riverside, San Bernardino and Perris. This decision is not just about Highgrove. But <u>our</u> plan will benefit the entire area in 3 different directions to help relieve our congested freeways.

We agree with Ann Mayer's statement in the Press Enterprise on Feb. 15, 2009 which reads:

"We have to put the stops where they will serve the most people". Building a station on a dead end track and ignoring the present Metrolink commuter rail system through Highgrove is not my idea of putting the stops where they will serve the most people. A message outlining the situation -- along with any other emergency information, such as evacuation routes or safety tips -can be released to the entire city or just to houses in the neighborhood affected.

There is no charge for the service and is as easy as going to the

Go to the City of Riverside's Web site at www.riversideca.gov, then to the E-services tab. Here, residents can fill out a short form to verify contact information and address. This site is also the location to update any personal contact details in order to ensure accuracy. It takes 24 hours for information to be updated into the Reverse 911 system.



Clinical Depression, hereafter referred to simply as depression, is a common disorder that strikes young and old, male and female. It is not a weakness or a character Understanding depression flaw. and receiving proper treatment can bring much needed relief from the physical and emotional pain of depression as well as support and understanding from those who live with and love the depressed person.

It is not commonly known that depression will cause a range of many physical symptoms in the body, not just emotional issues. Any pre-existing physical conditions may be exacerbated by depression. Some symptoms include headaches, muscle aches and joint pain, and chest pain that isn't heart related. Other common symptoms are digestive problems, and sleeping problems. There may also be

exhaustion and fatigue, dizziness and lightheadedness, and a change in appetite and weight- increase or loss. These physical symptoms may cloud the issue and delay the diagnosis of depression; however these symptoms must also be investigated to rule out any other causes.

Those who have not suffered from depression have a hard time understanding exactly what a depressed person feels. It is not simply feelings of sadness or feeling blue. The intensity will vary for each person and can vary from day to day. At its most intense, a person will feel so down that he won't want to get out of bed, won't want to go to work, visit friends, play with children or make love to his wife. The feeling has been described as a dark cloud over the head, a feeling as if there is a huge weight on the shoulders, and as desperately wanting to "crawl into a hole and pull it in after me". Frequently the depressed person will have the lack of will to go on and she simply will not see the point of living. The depth of the despair and hopelessness cannot be

underestimated; nor the danger if it is not treated appropriately.

Treatment of depression is more involved than simply taking medication. To properly and effectively treat depression, a multi-pronged plan is required. Medication, therapy, behavior modification, and most critical, a solid support system from family and friends are all necessary to successfully and completely treat depression. Depression causes the brain to undergo a chemical change, one that requires medication to be treated. There is a long list of possible medications that may be prescribed and each person will respond differently to each one. Because the medications to treat depression need to be gradually introduced, take time to take effect, and if necessary, take time to withdraw, the proper medication cannot always be quickly identified.


Therapy can be done in an individual or group setting; and by a number of different types of professionals and clergy. Behavior modification, done in conjunction with therapy is necessary as a person with clinical depression of long standing will have developed some habits that are counterproductive and self-defeating.


Most critical is the support system. The depressed person needs to feel that they are still love and accepted even though he is not feeling like himself. He needs to feel like he can express his feelings, no matter how depressing they are and not worry about others getting tired of him. Being the support system for a depressed person is a tough task but it is so important. The support of loved ones is the most important medicine and therapy a person can get.

Depression is a very serious illness; one that can ruin lives, and in the worst cases, cause death by suicide. If a clinically depressed person has supportive and understanding family and friends, there will be less resistance to seeking treatment for depression. It is critical that depression be treated appropriately and effectively.



told me they were getting worried that the lions had eaten me. With that, we headed home toward Stratford leaving this strange and wonderful place and time behind.






